On the last occasion I was denied entry, I had addressed letter to Registrar J(IV), pointing out to him the humiliation at the hands of Security persons, but no action on the letter was taken

Today, I came to Supreme Court to assist Mr. Mattiews Negumpara, my senior in Sabrimala Case, first I was stopped at (5021) D OUT Gate, after speaking to Col. K B Marwah, I was let in, again was stopped at D IN gate, I was denied entry again only on the instructions of K B Marwah, I was pained, flabbergasted, humiliated that without there being circular/judgement/notice. I repeatedly called Col K B Marwah(9560711005) sent him messages, SMS (Copies are enclosed) but it was on his instructions I was denied entry, I had no option left but to address this letter to your Lordships

I am appearing as Party- in - person in SLP 1 of 2019 which is listed before your-lordships court as item 10, I have already intimated this to Col K B Marah but yet he has denied entry to court on 08.02.2019,

I must not burden your lordships with other materials which are in support of Kirpan, as the constitution in plain and crystal-clear terms allows wearying and carrying of Kirpans, and there is no legislation/rule to regulate the size of Kirpan, and this right is legislation/rule to an area under Part III of Constitution of

I also plead before your lordships to ensure that young lawyers like me are not humiliated, insulted, tortured, and appropriate instructions are issued to Security department, so that not only i but other Sikhs too are allowed to wear and carry kirpan in court premises and argue SLP 1 of 2019 which is listed before Your Lordships court on 08.02.2019, item 10.
