- 1. It is humbly submitted that the Petitioner herein has been suo moto impleaded in the above mentioned Public Interest Litigation as a Respondent.
- 2. I state that on the hearing dated 25.04.2019, the Hon'ble Bench of this Court had directed that a meeting of the technocrats of WhatsApp, Google, Youtube, Twitter and Facebook with the officers of the Law Enforcement Agencies be held between May 20, 2019 May 27, 2019.
- 3. I state that the order specifies the object of the said meeting as follows:

"We direct, Government of Tamil Nadu, represented by the Chief Secretary to the Government, to arrange for an interactive meeting of all technocrats of WhatsApp, Google, Youtube, Twitter and Facebook, with the officers of the Law Enforcement Agencies, including Cyber Cell, and officials from the Information and Technology Department, Government of Tamil Nadu, between 20th and 27th of May 2019. Intermediaries shall also co-ordinate and inform the duties of the Chief Secretary, Government of Tamil Nadu, well in advance."

4. I state that the Petitioner is extremely supportive of the cause of the said meeting. However, since the Petitioner Company does not have any corporate presence in India, arrangements are underway to send the most suitable person, in terms of experience, knowledge, and language





capability to attend this meeting on behalf of the Petitioner. Mr. Chaitanya Ramachandran, who is the most suitable person to attend this meeting, is not based out of India. Owing to his prior commitments, Mr. Ramachandran will be in a position to make himself available for the aforesaid meeting in the first week of June, 2019. This being an extremely important meeting, the Petitioner is committed to depute the most suitable employee for this meeting who is well versed with the intricacies of this business and can represent the Petitioner in the best manner possible so as to ensure that the meeting is fruitful in all respects.

- 5. I state that the extension of time sought for is on bonafide grounds and shall not affect the main proceedings in any manner. The Respondents will also not suffer any hardship due to this indulgence sought for from this Hon'ble Court by the Petitioner herein. Per contra if it is insisted that no extension shall be granted, it will put the Petitioner to immense hardship and will render the purpose behind holding this meeting redundant since desired outcome is unlikely to be achieved if a Petitioner is compelled to compromise on the officer it deems fit to depute to attend this meeting.
- 6. I state that brief accommodation is being sought for and that the same is not a delaying tactic indulged by the Petitioner herein. In light of the above, the leave of this Hon'ble Court is sought for to permit the official of the Petitioner Company to meet the Chief Secretary, Government of Tamil Nadu and the Law Enforcement Agencies on any day in the first week of June 2019.
