Several Online News Ponets poeted a very disturbing news report on 27 08 2019 that an LLM STUDENT at Swami Shukdevanand Law College (S.S. Law College) from Shahlahanpur. Uttar Pradesh, is MISSING FOR LAST 3 DAYS since when she has accused Swami Chinmayanand, a former Union Minister and President of S.S. Law College, of harassment and destroying life of Several girls. As per the web-report, SHE HAS GONE MISSING FROM HER COLLEGE HOSTEL

The reports also attached a video of the LLM student wherein she is speaking about threat to her and her family's life. As per the report, even her mother also does not have any due about her, though the mother says that the last she visited her was on Raksha Bandhan i.e. on 15.08.2019 and she told her mother that "IF MY PHONE GOES OFF FOR A LONGER DURATION THEN UNDERSTAND THAT I AM IN TROUBLE. My phone goes off only when it is not in my hands". The mother has been quoted as saying- "My girl was going through a lot of pain and trouble but didn't divulge much. She told me she was being sent to Nainttal by her college administration." A copy of the Online Reports of National Herald, Scroll, the Outlook, are attached herewith for ready reference as Annexure A. B. C. respectively, and the video clipping can be shown from the mobile of the undersigned.

Your lordships, we the undersigned members of the legal fraternity and practicing lawyers of this Hon'ble Court are extremely disturbed and concerned about the wellbeing of the girl concerned. We as a society cannot

allow another 'Unnao case" to happen. This Hon'ble Court has been interfering in letter petitions when it comes to protection of human rights.

We therefore beseech this Hon'ble Court to take suo moto cognizance of the issue and would pray for immediate notices to be issued to the following to take immediate action to trace the girl, give her and her family necessary protections, and file status report say within 2 days:-

- ii) The Director General of Police,
