Respected Members,

The Executive Committee is happy to inform that we have received the permission from competent authority to vaccinate our members and their families between the age group of 18 – 44 years at Delhi Government Health Centre, Supreme Court Premises w.e.f. 17.05.2021.

Now, therefore, please find the new guidelines for vaccination of members and their families in Delhi Government Health Centre, Supreme Court Premises:

FOR AGE GROUP OF 45 YEARS AND ABOVE

- 1. Walk in vaccination drive will continue in the same manner as was going on earlier, i.e., First Come First Serve basis.
- 2. Number of people to be vaccinated per day is now **limited** to **50**.
- 3. Members should carry any one of the following photo IDs
 - i. Aadhar card
 - ii. Election Voter ID Card
 - iii. PAN Card
 - iv. Passport
- Timing of vaccination: 1:30 PM 4 PM on all working days, i.e., from Monday to Friday except on any national/ Gazetted holiday.

FOR AGE GROUP OF 18 – 44 YEARS

- 1. Vaccination will be administered to 50 persons only.
- Vaccination will be administered to the said 50 persons only by appointment and no walk in request will be entertained.

- 4. Members will be called by the SCBA Office 2 days in advance informing about their vaccination slot.
- 5. As there is shortage of vaccine, and the said program could be initiated only after persistent efforts of our President, Shri Vikas Singh (Sr.), in case any member do not turn up on the date of appointment, his request for vaccination will be kept at the bottom of all the applications pending with SCBA.
- 6. As the shelf life of an opened vaccine vial is 3 hours and to ensure not even a single dose is wasted, we would be calling 10 persons in addition and anyone left on the particular day will be administered vaccine on the 3 day.
