The 2<sup>nd</sup> National Lok Adalat of the year 2025 is scheduled to be organized in 28 States and Union Territories on 10<sup>th</sup> May 2025 by the Legal Services Authorities, under the aegis of the National Legal Services Authority (NALSA) and the esteemed leadership of Hon'ble Mr. Justice Sanjiv Khanna, Chief Justice of India and Patron-in-Chief, NALSA, and Hon'ble Mr. Justice B.R. Gavai, Chief Justice of India-Designate and Executive Chairman, NALSA. In a few States and UTs, where courts remain closed due to summer vacations, the National Lok Adalat will be held on later dates. It will be organized in Assam, Kerala, Puducherry, Tamil Nadu & Telangana on 14<sup>th</sup> June 2025, Andaman & Nicobar Islands on 21<sup>st</sup> June 2025, Andhra Pradesh on 05<sup>th</sup> July 2025, and Gujarat & Karnataka on 12<sup>th</sup> July 2025.

The forthcoming National Lok Adalat will serve as a significant opportunity for parties to resolve a diverse range of disputes at both pre-litigation and pending stages. Matters to be taken up include criminal compoundable offenses, traffic challans, plea bargaining, revenue cases, bank recovery matters, motor accident claims, cheque dishonour cases, labour disputes, matrimonial disputes (excluding divorce cases), land acquisition cases, IPR matters, consumer matters, and other civil cases. This

movement furthers NALSA's mission to ensure that justice is delivered in a manner that is inclusive, timely, and citizen-centric.
