NOTIFICATION: CLAT 2026 RESULTS

The Common Law Admission Test 2026 (CLAT 2026) was conducted on Sunday, December 07, 2025, from 2:00 P.M. to 4:00 P.M. at **156 Test Centres in 25 States and 4 Union Territories across India**. CLAT 2026 scores were tabulated and verified on December 14 and 15, 2026. They were placed before the Governing Body of the Consortium of NLUs (the “Consortium”) on December 16, 2025 for their consideration and approval. The Governing Body of the Consortium approved the same.

Candidates can download their official CLAT 2026 scorecards by logging into their account on the CLAT 2026 portal through the website of the Consortium.

- CLAT 2026 UG had 5 sections, with a total of 120 questions.1 question was withdrawn in the Provisional Answer Key and there is no change in the provisional answer key or to any questions. Accordingly, the evaluation of candidates for the CLAT 2026 UG shall be out of 119 marks based on the provisional answer key.
- The highest mark secured in **CLAT 2026 UG is 112.75**

- CLAT 2026 PG had one section comprising 120 questions.
- One Question was withdrawn in the Provisional Answer Key.
- The Answer Key for three question was changed and accordingly, the evaluation of candidates for the CLAT 2026 PG shall be out of 119 marks
- The highest mark secured in **CLAT 2026 PG is 104.25**

The overall attendance percentage for CLAT 2026 was **96.01%**. Of the candidates who appeared for CLAT 2026, **57%** are Females, **43%** are Males, and **9** candidates are Transgender. The Consortium provided extensive support to all candidates who requested
