WHEREAS the Petitioner above named through his Advocate Sri R Vijay Gopal presented this Petition under Article 226 of the Constitution of India praying that in the

circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Direction or Order more particularly one in the nature of Writ of Mandamus and.

- 1. To Declare the issuing of executive order (viz. i.e. Memo vide Memo No. 6480-P/General.A1 /2024, dated. 29/11/2024. issued by the Respondent No. 1 (Home Department), permitting exhibition of cinemas between 1.30 am to 8.30 am as contrary to Rule 12 (2) read with cinemas licensing conditions in Form-B (condition 12 (43) of the Cinemas (Regulations) Rules 1970) as arbitrary, illegal and set aside the same and consequentially prohibit the Respondent No. 1 (Home Dept.) from issuing executive orders contrary to the licensing conditions envisaged under the Cinemas Regulation Act 1955 and Cinemas Regulation Rules 1970 hereon and uphold Article 14 of the Constitution of India
- 2. Consequentially to direct Respondent No. 1 (Home Dept.) to consider issuing rule making minimum ninety (90) minutes duration mandatory between two shows at any standalone theatre in Telangana so as to manage crowds and avoid stampedes occurring with 600 plus cinema goers exiting/entering a theatre
- 3. Consequentially to direct the Respondent No 1 (Home Dept.) to ensure the cinemas license holders under the Cinemas Regulation Act 1955, do not resort victorial publicity or use fire crackers or inflammable material, as prohibited under License Conditions outlined in Form-B, i.e. condition 12 (14) and prohibit usage of fire crackers or inflammable material condition 12 (29) and (31), etc. and to issue necessary orders to all Cinemas Licensing Authorities in Telangana, to ensure the licensing conditions of Form-B of the Cinemas Regulation Rules 1970 are implemented scrupulously;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri R Vijay Gopal Advocate for the Petitioner, directed issue of notice to the Respondent No. 4 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No. 1 (Home Dept.) to not issue any orders in by whatsoever name, allowing any shows between 1.30 am 8.30 am 1<sup>st</sup> in Telangana, pending disposal of WP No. 37007 of 2024, on the file of the High Court.

The Court made the following

#### ORDER:

Heard Mr. Md. Sultana Basha, Mr. Vijay Gopal, Mr. Mahesh Mamidala and Mr. P. Srinivas Reddy, learned counsel for the petitioners and Mr. Mahesh Raje, learned Government Pleader for Home.

Notice to respondents No.2 and 3 in WP.No.1184 of 2025, notice to respondents No.3 in WP.No.1189of 2025, notice to respondents No.2 and 3 in WP.No.33923 of 2024 and notice to respondents No.4 in WP.No.37007 of 2024.

Learned counsel for the petitioners submitted that pursuant to the order dated 10.01.2025 passed by this Court, the Government of Telangana has reviewed its decision dated 08.01.2025 and by Memo.No.109-P/Genl/A1/2025 dated 11.01.2025 decided not to allow Benefit Shows hereinafter. It was further decided that early morning shows in future will not be permitted until public interest, health and safety are duly considered.

Mr. Vijay Gopal, learned counsel for the petitioners in WP.No.1189 of 2025 and 37007 of 2024 submitted that as per License Condition 12(43) in Form B License for Cinematograph Exhibition under the A.P. Cinema (Regulations) Rules, 1970, 'the licensee shall now allow any performance or exhibit any film by means of a cinematograph before 8.40 a.m. or after 1.30 a.m.'. Learned counsel submitted that children, more particularly, minors should not be permitted to watch movies during the late hours, as otherwise, it would have adverse impact on their physical and mental health. The last show in the multiplexes run until 01.30 AM and there are no restrictions in place regulating entry of minors in theatres during late night shows.

Learned counsel further submitted that the Government should have taken a prompt decision for regulating entry of minors in theatres, more particularly, in view of the unfortunate stampede incident during the benefit show of 'Pushpa - 2' in Sandhya Theatre, which lead to grievous injuries to a minor boy and death of his mother.

In the considered opinion of this Court, the children below 16 years should not be permitted to watch late night movie shows after 11 PM in theatres and multiplexes.

In the circumstances, the respondent No.1 is directed to consult all the stake holders and take necessary decision in that regard and issue instructions to all concerned for regulating entry of children below sixteen (16) years in theatres/multiplexes before 11 AM and after 11 PM. Till such decision is taken

the respondents shall not allow children below 16 years to watch movies after 11 PM.
