O R D E R

Learned ASG submits that when the Civil Appeal was listed for final hearing, the Government of Karnataka, Department of Commercial Taxes have issued a notice dated 09.06.2025 requiring the petitioner to discharge the liability within seven days even though there is an interim order by this Court passed on 03.05.2010 which has stayed the recovery of demand sought by the respondent for the period between April, 2005 and July, 2008. Now, the subsequent demand has been raised for the period of July, 2008 to March, 2014. Even though this Court is in seisin of the matter.

2. Issue notice on I.A. No. 49068/2025 to the respondent.
3. List the Civil Appeal in the 2nd week of August.
4. In the meanwhile the demand as per the endorsement dated 09.06.2025 issued by Government of Karnataka, Department of Commercial Taxes shall remain stayed till the next date of hearing.
