1. On the day of sitting, **after completion of the work of the Division Bench** at Dharwad and Kalaburagi Benches, Hon’ble Judges sitting in Division Bench will sit single and take up Single Bench matters, as notified above.
2. No appeals, Petitions or Applications and any other papers of civil nature will be received during the Vacation, except in cases where **urgent** interim orders like stay orders, interim directions and temporary injunctions etc., are sought.

3. No Criminal Appeals, Criminal Revision Petitions, Criminal Petitions will be received during vacation, except in cases where **urgent** orders, stay orders and interim directions etc., are sought.

4. Matters of the nature referred to above are permitted to be filed at Principal Bench, Bengaluru and at Dharwad and Kalaburagi Benches between 10.00 AM to 12.30 PM, except on Vacation Court sitting days. On Vacation Court sitting days, papers will be received from 10.00 AM to 3.30 PM. E-filing shall also be permitted through E-filing portal.

6. Motions to take up pending case/s shall be made before the respective Benches on the Vacation Sitting Day narrating the urgency by filing a memo.

7. Vakalathnama, Process Fee and Process memos in all pending matters will be received in the respective counters during Vacation between 10.00 AM to 12.30 PM, except on Vacation Court sitting days. On Vacation Court sitting day papers will be received from 10.00 AM to 3.30 PM in the Principal Bench, Bengaluru and at Dharwad and Kalaburagi Benches.
