ORAL ORDER

- 1. The present writ petition has been filed essentially impugning the election of respondent Nos.3 to 7 who got elected to the Karnataka State Cricket Association, respondent No.8. These members were elected on 03.10.2019 for a period of three years. The three years' period got expired long back. We are in the year 2025. Respondent No.8 has already announced fresh elections of its Managing Committee, and the elections are scheduled to be held on 30.11.2025.
- 2. In view of the aforesaid facts, nothing survives in this writ petition insofar as the challenge to the election of respondent Nos.3 to 7 is concerned as respondent Nos.3 to 7 have already



completed their tenure in the Managing Committee of respondent No.8, and respondent No.8 has announced the fresh elections.

- 3. We, therefore, dispose of this writ petition with a direction to respondent No.8 to conduct the fresh elections strictly in accordance with the prevailing rules, regulations and by laws of the respondent No.8.
- 4. Any person, who is qualified to contest, may participate in the elections, if one so desires.

In view of disposal of the writ petition, pending interlocutory applications, if any, do not survive for consideration and accordingly, they stand disposed of.
