- b.) Candidate must have had not less than 65% marks in the last 2 years of his 5-year Law Course in **aggregate/average**, without more than 4 repeats/ improvements in any subject of the curriculum in the last 2 years.
- c.) Candidate must have had not less than **75 % attendance in the last 2 years** of his 5-year law course in aggregate/average of the 2 years.
- d.) The annual cumulative family income (of Father, Mother, Unmarried Brother or Unmarried Sister in the last 3 financial years on the date of application has been equal or less than **Rs. 10 lakhs per annum**, including the latest / last financial year as per the ITR filed with the IT department.
- e.) Candidate undertakes to fulfil the affidavits & undertaking form appended to this application form as **Appendix** containing all the conditions and stipulations pertaining to the duration of scholarship and stipend.

The writeup must disclose, how, in next 10 years, the candidate aims and intends to serve the needy sections of the society as a lawyer, particularly those for whom justice is inaccessible and unaffordable. **Writeup must be of maximum 1000 words.** Typed (not handwritten) write up shall be rejected along with the whole application, even if the candidate is otherwise eligible. **The writeup in Hindi shall equally appreciated.**
- B.** The candidate must also provide a separate **500-word writeup in his own handwriting and not typed** about the basic values and principles of life he believes and those from which departure is completely impermissible. This writeup must disclose those values and ethics, which the candidate feels are most relevant for joining litigation as a career and way of life. The writeup may be given either in Hindi or in English and no other language. **The writeup in Hindi shall equally appreciated.** Typed (not handwritten) write up shall be rejected along with the whole application, even if the candidate is otherwise eligible.

I consent for being subjected to **monthly appraisals/evaluations** by my employer office to the CAN Foundation, I shall be joining for the first 6 months of my period of practice, to be provided on the basis of my performance, conduct, commitment, etc. If any untoward incident/conduct of mine is reported to the CAN Foundation of any misbehaviour, misconduct or disrespect on my part, then CAN foundation shall be free to initiate appropriate process of enquiry and discontinue the scholarships granted to me at any stage of validity of said scholarships.
