| 2 | To consider the matter regarding the collection of funds to be utilized for relief to the victims of Corona Virus (Covid-19) infection. | <p>Keeping in view the projections on account of Corona Virus (Covid-19) Infection, the prohibitions and impact thereof, it is resolved to effect the collection of amount to be utilized for the welfare of the victims.</p> <p>Accordingly, contribution shall be made in the following manner: -</p> <ol style="list-style-type: none"> 1. The Chief Justice and all Judges of the High Court of Jammu and Kashmir may make a contribution of Rs. 25,000/- each. 2. All the District Judges of the State of J&K may contribute Rs. 15,000/- each. 3. All Sub-Judges /Civil Judges (Senior Division) may contribute Rs. 10,000/- each. |

All Non-gazetted staff of the High Court and Subordinate Courts may contribute one day's salary.</div> <div>7. Registrars (Judicial) of both the Wings of the High Court of Jammu and Kashmir at Jammu and Srinagar, after collecting the amount of contribution so made at their respective Wings, shall credit the same in the Bank Account opened for the purpose under intimation to the Registrar General.</div> <div>8. All the Principal District and Sessions Judges of the Districts of the State of J&K, after collecting the amount of contribution relating to their respective Districts, shall also credit the same in the Bank Account opened for the purpose under intimation to the Registrar General.</div> |
