

The Delhi Police is also directed to publish the details of all the unidentified dead bodies that are lying in the various hospital mortuaries – both under the control of Central Government as well as that of Govt. of NCT of Delhi – along with their photographs and other details, including the specifics of the post-mortem conducted thereon as also the DNA samples preserved; on their official website forthwith.
