The writ petition has been heard by way of video conferencing.

In pursuance to the last order, an additional affidavit has been filed. It is pertinent to mention that the present public interest litigation has been filed seeking an appropriate writ, order or direction to the respondents to supply free laptop/android mobile phone/I Pad with high speed internet to children belonging to EWS/DG category so that they can attend their classes through video conferencing just like fee paying students in their classes.

Petitioner also seeks a direction to the Central Government to disburse its share of costs for construction of hostel buildings as prescribed under Section 7 of the Right to Education Act, 2009.

Learned counsel for petitioner states that EWS/DG students in private unaided schools are unable to attend online classes due to non-availability of mobile phones/computers. He submits that the respondents by not supplying computers/mobile phones to EWS/DG category students in private unaided schools are violating not only the provisions of Right to Education Act, but also Articles 21 and 21A of the Constitution of India.
