ELIGIBILITY CRITERIA FOR AUTHORS

Professors, Researchers, Legal Practitioners and Students from all over the world are invited to submit their Research Paper/ Article on the theme of the conference.

GUIDELINES FOR AUTHORS

- The Article/ Paper must be in English language only.
- The submission shall be made in Microsoft Word format (.doc or .docx).
- Co-authorship is allowed upto maximum of two authors.
- Only one submission is allowed per author/ team and multiple entries will lead to disqualification.
- There should not be any form of identification such as name of the author/ team, name of University/College on the article.
- The article/paper must contain an abstract of not more than 500 words including atleast five keywords.
- The word limit of the article/paper is 3000-7000 words including footnotes and abstract.
- The article/paper should be an original work of the author/team that has not been published elsewhere or has not been submitted to any other organisation.

FORMATTING GUIDELINES

- Main Body Font: Times New Roman, Font Size: 12, Line Spacing: 1.5, Alignment: Justified
- Footnotes Font: Times New Roman, Font Size: 10, Line Spacing: 1.0, Alignment: Justified
- Margins should be 1 inch or 2.54 cm on all sides.
- The authors shall follow the Harvard Bluebook Citation 21st Edition only.
