1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The Chanakya National Law University, Patna was established on 15th July 2006 through an ordinance which has been subsequently replaced by Chanakya National Law University Act, 2006 (Bihar Act No. 24 of 2006). The University was granted approval of affiliation by Bar Council of India vide notification No. BCI: D: 1507 / 2006 (LE: Mtg) dated 18th September, 2006. The University has been included in the list of Universities maintained by the University Grants Commission under Section 2 (f) of the UGC Act, 1956 vide notification no. F.9-24/2006(CPP-I) dated 26th October, 2006. The University is declared eligible to receive Central Assistance in terms of Rules framed under Section 12 (B) of the University Grants Commission Act, 1956 vide notification no. F. No. 9-24/2006 (CPP-I/PU) dated 11th January, 2012. CNLU is committed to the aspirations of the legal fraternity providing quality multi-disciplinary legal education for building strong bar and bench. Hon'ble Judges of the Supreme Court and High Courts, subordinate Judiciary, Senior Advocates, Jurists and eminent educationists have been participating to promote CNLU in its teaching and research programmes. CNLU maintains financial autonomy equipped with the state-of-art- infrastructure for imparting of legal education. CNLU faculties are experienced academicians, proactively involved in training and imparting skills to younger generation. Our sincere endeavour is to make legal and juristic education, as an instrument of social, political and economic change. We have objective to shape our students as social transformers as per the Preamble of the Constitution. Our mission is to equip students to face the socio-economic legal challenges of the new millennium, upholding the philosophy of Human Rights to achieve Global Justice. It has been our endeavours to carve a distinct identity in the constellation of National Law Universities in India. The university publishes its peer reviewed journals- titled CNLU Law Journal, JAIRIPA (E-IPR journal), I P BULLETINRE (E-IPR magazine), and the CHANAKYA LAW REVIEW (E-Multidisciplinary journal of fundamental Research) periodically. CNLU students have proved excellence in the National and International level Moot Court Competitions, Debates and Parliamentary Debates. The University has entered into MoUs for various developmental programs.

To improve the ability to analyse and present for the benefit of the public-contemporary issues of public concern and their legal implications. To collaborate with Universities, research institutions, NGOs, Centres nationally and internationally to achieve the objectives of the University. To publish periodicals, treatises, study books, reports, journals and other literature on all subjects relating to law and applied studies. To promote legal awareness for achieving social and economic justice for all. Mission

Legal education is a social justice education. CNLU envisions to produce law graduates and skilled legal professional through systemic teaching of syllabus, training in advocacy and internship in present legal regime including alternative dispute resolution. In this process the university is using the ICT to maximise the horizon of teaching and learning. The curriculum has been designed and updated time to time as per the requirement of society, business and industries. The university also concentrates on preparing lawyers as social engineers. The university is engaged in teaching and research in law and social sciences (interdisciplinary and multidisciplinary). The moot training and internship and research writing are the regular features of the curriculum for developing practical skill. The students are imparted training in social issues through NSS, holding street plays, legal aid, community awareness and medical check-up camps. The Centre for Child Rights in collaboration with UNICEF has been sensitizing for prevention of child abuse.

Faculty undergo orientation and refresher courses, capacity building programmes, other academic programmes, training, resource mobilization, conferences, debates, seminar etc. The university periodically organizes national seminars. Students are regularly sent for National and International Moot Court Competitions, Debates, Sports and Cultural events. Teachers are encouraged to write books and publish articles in reputed journals. Teachers and students both are provided interactive facilities with peers. Senior students regularly interact with the junior in regular day to day moot court and debatery activities. The university facilitates doctoral and Post-doctoral research in Law by providing academic and research guidance and infrastructural facilities. There is regular interaction with the legal fraternity - eminent advocates, judges of the apex and the subordinate courts, law makers and law persons. The law firms and HR personnel from leading corporates are regular invitees.

It is the result of the missionary teaching and learning in CNLU that many students could have their place in LL.M. courses in U.K, U.S.A., Singapore. The law firms are recruiting our graduates regularly. Many students have been selected in judicial services and teaching profession in the states of India.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

The Chanakya national Law university has been established by the Act of Bihar legislature in the year 2006. It is one of the National Law University in India imparting quality legal education in integrated UG courses in B.A. LL.B and BBA.LL.B. Courses. The University has a campus in the Heart of Patna City. The students are admitted through CLAT entrance test. They are our first strength. The University has appointed experienced teachers with attitude of teaching—learning and research. The teachers have been working as mentor /Guru for the total development of the students and making them socially and professionally a national asset. This is evidenced in the recruitment and placements. Around more than hundered students have been selected in the civil judiciary examinations in various states of India; Public sector undertaking ,private law firms ,litigation at various High courts and Supreme court of India. Our Alumni, fourteen batches pass out, are our strength. CNLU has a very good infrastructure, one of the best in India with adequate number of class rooms facility hostels, playground, moot halls, conference halls, etc. The Chief Justice of Patna High Court is the Hon'ble chancellor of the University. It has support from the all the honourable judges from lower court, High court,

and Supreme Court, Bihar Judicial Academy ,Bihar Government Institutions, Bihar Legal Services Authority etc. CNLU has a rich library with all infrastructure for research and study. Our doctoral program is appreciated. The system of teaching, learning, examination and evaluation is honest and transparent. The LL.M. courses are high in demand. The strength lies in cooperation, coordination and collaboration among students –teachers, staff and administration. The parents of our students are our strength who render full support to us. The gender equity environment, green campus adequate residential facility to staff, adequate security are our strength. The cultural harmony and respect between teacher-and students have built-up parental bonding. We are proud of having human capital, technological gadgets, physical infrastructure, and knowledge capital and harmonious relations. The University is working for social justice cause. Some of the Alumni have been appointed faculty of this university.

Institutional Weakness

Every institution has some weaknesses, especially when it is in its teens—the growth period. CNLU has entered into fifteenth year of establishment. It has established its remarkable position in India in teaching and research it has been collaborating every day with different institutions through MOU. But it lack Industrial/corporate Collaboration and funding. The University has established centres—but research projects are wanting. The university has only one Chair in Panchayati Raj institution, IPR Chairs are still wanting. Although CNLU has good IT infrastructure but Automation is still in process. The number of staff is available but requires training in skill development and documentation. Almost all staff are regular employees, barring few, availing seventh pay commission facilities and other social securities. Teachers training and grooming is a regular process, but Academic staff college (HRDC) is wanting. The university feels excessive regulatory obedience in its expansion programs. The most serious constraint is the Limited space, i.e.18 acres of land which is a constraint/barrier in the expansion programs. The university has no rain harvesting and waste management and water recycling facility

Institutional Opportunity

Legal education is a social justice education .Law professionals are in great demand in all sectors –judiciary, executive, trade and commerce, education, local self-governance, advocacy etc. Our consistent endeavour to consolidate academic ambiance has yielded rich dividends that is duly manifested by great heights scaled by our students. Their resounding success in their career in various law firms and other prestigious competitions speaks volumes of truth about their mettle. Many of our students have brought laurels by getting selected as law clerks in Supreme Court of India. Former Chief Justice of India Hon'ble Mr. Justice Altamas Kabir has declared in the first convocation the high calibre demonstrated by the CNLU students. Many graduates of the University have taken admission in the most prestigious and esteemed universities of India and abroad and successfully completed their advanced studies. Our collaboration with Vistula University of Poland has yielded positive results as it has provided golden opportunity to students and faculty of both sides to exchange their ideas in a more wholesome and comprehensive manner. We are collaborating with some reputed Universities and Institutions such as NLSUI Bangalore, ASIAN School of Cyber Law, Pune and MATS University, Raipur through MoUs. Under our academic social responsibility, we have collaborated with UNICEF and established a Centre for Child Rights for bringing enlightened awareness among the stakeholders and are working closely with Centre for Child and the Law, NLSIU, Bangalore. With the expansion of the horizon in trade business, nationally and internationally along with growing population, the opportunities shall be bouncing. With LPG and foreign direct investment, the opportunity in legal education sector is limited to sky. Every paper/Subject of law opens opportunity for legal professionals. The more legislations, the more opportunities. The students have

great opportunities for study and research abroad with full scholarship.

Institutional Challenge

Of course opportunities are never without challenges. And challenges never go in vain. Legal education is a social justice education. It requires interdisciplinary, multidisciplinary and cross disciplinary understanding. So time constraint is a great challenge. The six month time period is not enough to complete the syllabus. In general most of the curriculum is completed well within the specified time limit. However if any faculty foresees that it would be difficult to complete the syllabus within time due to unforeseen holidays affecting their schedule then, they take extra classes in the afternoon session to complete the syllabus well within time so that students can get sufficient time to prepare for their end semester examination. The university has enlisted outside experts to provide facilities to the scholars residing outside. Access to online data bases subscribed by the University through comprehensive Wi-Fi Network, which helps the students in accessing the latest possible information anytime. Project funding for research is a challenge for centres. The regulatory body's directives under the new education policy is a great challenge. The educational institutions without quality consciousness is a threat to quality oriented educational institution. The social burden with regulatory compulsion on institution is a challenge with Excessive of administrative work assignment to faculty.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

CNLU offers five years integrated law courses at the UG level B.A., LL.B. (Hons.), B.B.A., LL.B. (Hons.); LL.M (one year), Doctoral and Post-Doctoral. The curriculum is developed under the policies laid down by the Academic Planning Board and adopted by the Academic Council. The Under-Graduate five-year integrated course is divided into ten semesters. CNLU students study law and social sciences subjects comprising, compulsory papers including substantive and procedural laws, clinical courses, moot court exercise and internships, seminar papers and optional papers from the list provided by the Bar Council of India. The pedagogical principles include training and sharpening of the professional skills. The curriculum includes both theoretical and practical components- exposure to professional working environment through internships, planned and executed by the Internship and Placement Cell. Legal Aid Cell ensures learning about the matrix of Law in the real world. Professional training is imparted through Moot Court participation and competitions at internal and external levels. The university revises and updates its curriculum on regular basis. At the end of each semester, faculty members meet, review and update the existing syllabus. There is formal feedback system wherein the quality of teaching, lecture plan and cover up are tested every semester. Before the end of the semester, the papers are allotted as per their choice / preference / expertise for the purposes of utilizing the vacation for preparation of lecture plan. The new subjects as electives/optional have been introduced in BA.LL.B(H). BBA.LL.B(H). Courses. In LL.M., two specialisations -constitutional law and corporate law have been introduced. The subject teachers are authorized to develop their course structure according to the directives of BCI, UGC and Industrial /corporate requirements. The doctoral programs, especially course work, are also revised as per UGC notifications, all are analysed and approved by the Academic Council and notified by the Registrar.

Teaching-learning and Evaluation

Students are admitted through CLAT test on merit. Teaching-learning and evaluation is the core activity of the university. The classroom teaching is interactive supported by the modern technology with OPAC catalogue system in library. Learning is student centric and participatory. A student has to clear minimum eight out of ten prescribed papers for the year in order to be eligible for promotion to the next higher class. The University offers remedial classes to weaker students. Seminars, workshops and Conferences are organized to ensure discussion on latest developments. Legal Aid Committee and Child Rights Centre actively involve students in legal aid and awareness programmes. Research project are assigned in the beginning of the semester in each paper. Students have to prepare their project by researching, data collection and analysis and give oral presentation. Every student has to attend minimum 75% of the classes for each subject to be eligible to appear for the End-Semester examination. The practical/clinical/drafting papers are taught by senior advocates. Court Room practises are organised through Moot Court and court visits, ADR and Legal Aid Cell. CNLU provides continuous evaluation system by way of conducting Mid-term Test, Project Presentation and annual endsemester examination. Students have to obtain 50% in each subject as well as project report and oral presentation. The annual end-semester Examination carries 60 marks. Repeat examinations are conducted to enable the students to clear the backlog at the earliest for their promotion to the next year. Question Papers are set by the teacher who teaches the subject and is evaluated by the same teacher. After evaluation, students are shown evaluated answer sheets. Teachers explain evaluation and marking. Dissatisfied Student can request for re-evaluation by external examiners. University has adopted Cumulative Grade Point Average (CGPA) system of grading. The Objective of teaching is to make students expert lawyer. Therefore, the students are imparted theoretical courses in the classroom, and practical courses, i.e. Moot court, Arbitration practices, Pleading Drafting and Conveyancing, Arbitration also. The Students undergo internship with NGOs, Law Firm, Advocates and Hon'ble Judges. The Teaching is based on student centric, participative, experimental, and problem solving.

Research, Innovations and Extension

Legal Methods and Legal Research Methodology are an important component in the First Year of the Undergraduate Programme. Students are made well aware of the approaches to research and its importance to case law analysis, judicial reasoning and objectivity. This helps the students to prepare their research project in all the 5 years of the courses. This helps them in the Post-Graduate studies and Doctoral and Post-Doctoral Research. The university encourages its faculty to actively engage in research and extension work. The university is actively engaged in extension work by undertaking research and holding conferences through its Child Rights Centre, Legal Aid Centre, NSS and interaction with other educational institutions for furthering these research activities. The University has guidelines for research that facilitate smooth implementation of research project and schemes. The University has a strong Law and Social-Sciences faculty. The faculty members engaged in legal research consult the Social Sciences faculty, when relevant for their respective projects and vice-a-versa. Numbers of workshop/training programmes/ sensitization programmes were conducted since inception of the University. The University has organized a number of National and International conferences by inviting legal scholars, judges of Supreme Court and High Court. The University has allocated budget provision for financial support to students for National and International Moot Court Competitions. The University publishes CNLU Journal, E-JAIRIPA (IPR), I P BULLETIN (E-magazine), The Chanakya Law Review (Multidisciplinary) periodically.

Research is the primary concern of the University. CNLU imparts research oriented education to the undergraduate and post graduate students in terms of research project and Dissertation, respectively. This is

meant to inculcate creativity among them. CNLU runs Doctoral programs (Ph.D.) in law, social sciences with law, sciences with law, interdisciplinary/multidisciplinary. Here Post-Doctoral Programs (LL.D.) and D.Phil. (Non-Academic) programs run also. All the programmes are based on UGC regulations. The purpose of research is to create innovative environment in academics. In this way the University obtains new knowledge with is disseminated to the institutions through our students and scholars.

Infrastructure and Learning Resources

CNLU has developed eco-friendly academic oriented and community based Campus at Mithapur, Patna within 18 acres of land. There are spacious buildings for Administrative and Academic Blocks, Halls of residence for Boys and Girls, Faculty and Non-Teaching staffs' quarters, Gymnasium, Indoor & Outdoor Sports Facility and Two Guest Houses with all necessary amenities with Firefighting equipment installed, sprawling lawn with various types of plants add beauty to the landscape. The LIBRARY –"NISHANT NILAYAM", a magnificent building ,has an opulent collection of 20 thousand books, bound volumes of journals, different magazines, newspapers along with CD's and videos, online databases i.e., WESTLAW INDIA, MANUPATRA, HEIN ONLINE and JSTOR through INFLIBNET, E- CORPORATE LAW ADVISER, AIR, SCC ,internet services through NKN-NMEICT. University has subscribed a backup Internet connection of 180Mbps with secured Firewall cum UTM device namely FORTINET FORTIGATE 800C at server room with power backup. CNLU has a spacious moot court hall in library premises with a capacity to accommodate 200 persons. The Auditorium hall is under construction. Presently seminars are organised in academic hall no 7 with 200 capacity. The Boys and Girls Hostel are equipped with Aqua guard (RO) system, water cooler on each block and floor, separate geyser, high powered generator and Security Guards. Hostels have common rooms with indoor games facilities with Gymnasium and outdoor sports activities.

The University Health Centre (UHC) runs in the Campus with Resident Doctor and trained Nurse and Compounder, services are available at Academic Block, Girls Hostel and General Dispensary. It has basic facilities for indoor admissions, minor surgeries, resuscitation equipment, vaccinations, and sterilization of equipment and stock of medicines for routine and emergency ailments. It functions 24×7with ambulance service. BANK ATM services of Indian Bank and SBI are available. Online annual fee collection facility is available through SBI, Indian Bank and HDFC through payment gateway for CNLU students. Cafeteria and canteen facilities are available in the campus. The canteen is located in the mess area of boy's hostel & girl's hostel accessible to inmates, staff and visitors. The Vice-Chancellor and Registrar are also having a separate Bungalow.

Student Support and Progression

CNLU has a system in place for student support and mentoring. The faculty plays an active role to support the students. CNLU draws students from diverse backgrounds and from different regions all over India and facilitates government scholarship to all eligible. Academically weaker students are identified and teachers take extra care of them by taking tutorials. Also senior students act as mentors for students. Students go for Internship which is mandatory for 4 to 6 weeks after each semester. Faculty in-charge of placement cell creates awareness among the students regarding Job Opportunities. In addition to the academic and research activities faculty members also perform the functions of Advisors, Coordinator for different curricular, co-curricular and extra-curricular activities and also for other institutions whenever they seek for it. Under the supervision and guidance of faculty members students have brought several laurels.

CNLU has a very big library separately stablished in a huge building. It has more than 20000 books on various subjects of law and social sciences, Journals of National and International, Magazines and Various newspapers in English as well as Hindi. CNLU Library is also using Semi-automated system. KOHA, is being used for different housekeeping operations. Library subscribes various E-resources - SCC Online, AIR Database, Lexis India, WestLaw, HeinOnline, Manupatra, JSTOR, CLAOnline, Economic and Political Weekly, and Bar Bench, which can be accessed remotely using Website link. The library function under Circulation, Patron Management, Cataloguing, Serials, Acquisitions, Tools modules. There is Wi-Fi, Xerox, printing, and sufficient reading facilities available in the library. Organisation and management system under the supervision of the registrar, administrative officer, and academic coordinator for managing teaching and Non-Teaching staff. They are governed by employment agreement, Code of conduct rules and guidelines of the regulatory bodies. The executive council is the final authority of the university to regulate all the activities of the staff. The Staff orientation programme is conducted every three months in the university to motivate the staff for punctuality, regularity, sincerity, Inter-personal relationship. It is reflected in the work performance and peaceful work culture.

Governance, Leadership and Management

CNLU is established with a vision to produce excellent law graduates, academician, and researcher. Hon'ble Chief Justice of Patna High Court is the ex-officio Chancellor of CNLU. The General Council, Academic Council, Executive council, Finance Committee are the authorities. This plenary authority of the university formulates and review the broad policies and programmes, devise measures for development of the university. The Executive Council is the Chief Executive Authority which meets at least once in Four months under the chairmanship of the Vice-chancellor. It has administrative powers within the purview of the CNLU Act, 2006, frames Rules & Regulations. The Academic planning Board frames broad policies for future program under the chairmanship of Chancellor. Academic Council manages academic and related affairs, meets twice in a year. A Grievance Redressal Committee redresses any dispute in the university. The Finance Committee is responsible for financial budget and expenses, scrutinizes, recommends on financial matters to the Executive Council and General Council. The Vice-Chancellor, The Registrar, The Dean (Academics & The Law, Social sciences, Research and Development) and Head of the Department, officers of University. The Vice-Chancellor is competent appointment authority in consultation with the Chancellor on the recommendations of the selection committee constituted by the Executive Council as per prescribed guidelines. The Registrar is ex-officio secretary to Vice-chancellor and other bodies and convener for all meetings.

The Academic and Administration is managed through various committees under the supervision of the faculty-coordinator, Moot Court Committee, Internship and Placement Committee, Academic and Debating Committee, Cultural and Sports Committee, Hostel and Mess Welfare Committee. The administration of the University is fully decentralised and participatory with students. The IQAC sets standards and closely monitors their implementation. The vice-chancellor, Registrar, Deans, Heads of Committees, collectively control and regulate the activities. All the teachers have assigned administrative task along with teaching and research. The ICT tools – internet services, printers, fax, telephone, are used for this purpose. The installation of CCTV has made the administration comfortable to control and regulate the employees and student.

Institutional Values and Best Practices

The University endeavours to enforce innovative practices in teaching, learning and research. The administration, hostel management, campus and cleanliness, energy conservation, sports activities, NSS and

related activities are always reviewed. Teaching learning process is complemented with the latest technological teaching aids. Their resounding success in their career in various law firms and other prestigious competitions speaks volumes of truth about their mettle. Maintaining utmost transparency and objectivity in teaching, learning and evaluation mechanism is the second-best practices. It is evident from the improved academic performance of the students. The students participate in the National and International Moot Courts which is reimbursed.

The University is Composed of Administration, Teachers, and students. The objective of the university is achieving excellence in academics, legal professional skill, and research. The University Administration is divided into various committees comprising teachers and students. It helps the administration to encourage participatory management and smooth functioning to achieve desired goal. The teacher -student relation is primary for learning outcome. For this purposes, informal sports and games helps in reducing tension, develops faith, increases comfort level between them. The Interpersonal Relationship is the issues of every institution. The staff orientation program (SOP) defuses tension among employees and helps them realizing their potency and how much valuable they are. The academic planning through lecture plan, discussion in the faculty meetings, review of syllabus, updating of lecture plans are the best practices which boost up the moral of students and teachers also. Hence, decentralization in administration, Cooperation and Coordination among faculty members and fixing accountability and responsibility on administrative staff are key factors of best practices. The University has a Research and Mentoring Society in which the senior students help the junior students in the preparation of Moot Memorials with the help of subject expert teachers. They also help in mooting practices, debating, research writing and advocacy.

The legal language and research methods are to create lawyering in the students. Sociology of law, Law and literature, legal history, Sociology of development, Micro- Economics, Interdisciplinary subjects which have employability scop. These help in learning various laws. Family laws and labour laws have not only local, regional, and national importance, other than international also in private international disputes and international labour issues, respectively. The criminology penology and victimology have wider scop in profession locally nationally and globally also. The corporate law teaching creates ability in corporate lawyering and profession with taxation also. The Administrative law, international law, constitutional law opens the door to constitutional lawyering. The ADR opens the professional door to international arbitration worldwide. The teaching in intellectual property rights opens opportunities worldwide in trade and industries. The courses on Human Rights, Humanitarian Law explores opportunities to NGOs. The press and media laws have access to media profession as counsel. The Banking and Insurance Laws have great scope in these sectors. The introduction of Insolvency Laws has created wider scope for lawyers in Corporate and Business area. The contract Act has opened a vast scope in business sector in Real estate business. The BBA LL. B course curricula is business and professional oriented. Theses course curricula have specific outcome as per the nature and scope. 1.3 Curriculum Enrichment

1.3.1 Institution integrates crosscutting issues relevant to Professional Ethics ,Gender, Human Values ,Environment and Sustainability into the Curriculum

Response:

The legal education is a social justice education. The course design is as per the requirement of the profession but it has certain papers which cut across all the papers. Professional ethics is part of Advocate Act 1961 which describes the code of conduct of the lawyers, i.e. duty towards court, client's society and government. It is non-discriminatory equally applicable irrespective of religion, race cast gender, sex, rich or poor. It is codified law governing the profession which is essentially to achieve social justice goal. The

Integrated Graduates (B.A.LL.B. and BBA. LL.B) are taught in the fifth year of their curriculum. The students are taught Law relating to women and child, dealing with gender issues, their social constitutional, political, economic rights irrespective of religion race caste and class. The Human Rights and Humanitarian law are taught in fifth year tenth semester which is part of study. The study of sustainability in environmental law is a cross cutting issues. The rule of law under the constitutional law is a part of study in administrative laws also.

The interaction with trial Court Judges and lawyers are also helpful enriching the curriculum on rule of law and professional ethics. The interaction with alumni, who are practicing or doing jobs in government sector/ companies/ industries contribute in updating of design. CNLU has Child Rights Centre in collaboration with UNICEF. The gender related programs are routine work in collaboration with CNLU faculty and students. It is sensitizing the people of Bihar especially women on gender issues. Various programs are organised recurrently on women issues in CNLU. In the curriculum also, we have law relating to women and children. Special lectures are invited on trafficking on women, gender issues and how to protect women and get rid of such menaces. The under graduate course has Human Rights in the curriculum which is a source of value addition. CNLU also organises yoga and ethical values workshop for inculcating ethical values amongst students, teachers and staff. A teacher of psychology has been appointed as consultant for counselling to students. The MBBS doctor organises workshop on health and hygiene also which is a part of human values. The workshop on consumer issues on food security and food wastage is also frequently organised. CNLU is environmentally conscious which is reflected in its green campus as well as outreach programs in collaboration with Ministry of forest Government of Bihar. We have been teaching environmental law comprehensively. CNLU has been organising outreach swachhata programs also.

All the programs are interdisciplinary. CNLU follows the inference of National Knowledge Commission, expanding the domain of optional courses, understanding of professional ethics, Legal Aid programs, human rights, IPRs, Private International Laws, Humanitarian Law and Corporate laws etc. It is a socially sensitive and corporate / industry oriented.

2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Response:

The university organises orientation programme every year on the first day of the academic session for the

new students, where in the faculties and the vice chancellor interact with the students. They are apprised about the importance of legal education and professional scope. The university administration endeavours to alleviate the fear of ragging, encourages formal dialogue between the senior and the junior students. Anti-Ragging squads along with security officer, warden (Halls of Residence) and faculty members monitor and protect new students as per norms. Further the senior students also apprise them about the campus scenario and how best they can utilise their time effectively by being part of the varied campus activities. The University have a mechanism through which the differential requirements of the student population are analysed after admission and before the commencement of classes. The University orientation programme helps them in assessing their knowledge and importance of the subjects and Course. The university conducts remedial classes for those who fall short of attendance in particular paper in the next concerned semester or fail, in the afternoon session. Besides that, the students participate in the mooting and debating activities on everyday basis in the guidance of the concerned faculty. The university is very much concerned about the academic advancement of poor section of the society and thus regularly conducts study on their academic performance. The performance of slow learners and physically handicapped students is also analysed based on their academic activities and other performance indicators. In the study it has been found that the students, who belong to the weaker sections of the society, do lack in the areas of communication, presentation and writing skills. The medium of instruction being English poses a big challenge to them as most of them come from Hindi medium schools. This also has a bearing on their examination results which is reflected in the form of backlog papers and detention. Equal Opportunity Cell puts on extra efforts in ameliorating this situation as 50% of the students fall in this category. Once identified, such students are encouraged to participate in debates, moot court competitions and MUNs to sharpen their intellect and train them for excellence. They are also encouraged to publish articles in national and international journals to enhance their research writing ability. They also participate actively in conferences and seminars. In addition, the university has a very active legal aid cell which gives the students real time exposure to the practical aspects of law. Those students who are inclined to pursue their carrier in the field of judiciary and other legal services are encouraged in that direction and provided with extra inputs from the concerned faculty. Library facility is available to them till late night to facilitate their academic endeavours.

2.3 Teaching- Learning Process

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Response:

The course curriculum has been designed with reference to practical learning, participative and problemsolving syllabus. The lecture plan, deliberations in the class, question setting and evaluation, project

writing and group presentation all lead to professional goal. In the faculty meeting, these aspects are clearly explained, and teachers are groomed accordingly. All the faculty members are allotted subjects for the next semester as per their choice and expertise who are design the lecture plan, draft project topics, refer books and cases. All the concerned faculties present their teaching plan and outline of the proposed syllabus. This academic calendar is prepared as per the course curriculum requirement, uploaded on the university website. A list of all the allotted project topics is prepared and put on the notice board of each class for the concerned students. The faculty provides a complete syllabus to the students as soon as the academic session begins. The lectures are interactive with case law study. The students discuss and debate inside the class on topics and current issues so that everyone can participate in the learning process. Sometimes students are asked to make a small presentation on some important issues in the class. This also helps them in developing communication and presentation skills. Besides, the various academic activities such as project preparation for each subject, their viva-voce and question answer session help them in understanding the subject in a holistic manner. The overall focus is always on the students and the way by which their inner ability can be brought forward and make them realize their strengths. The moot court exercise in the part and parcel of the curriculum which is organised regularly. It is just like practical experiment to the science students. The students are sent to courts, internship which provide them professional exposure. The question set by teachers are application based and standard evaluation motivates the students to work hard. The project work is compulsory in each paper for twenty marks.

The university on a regular basis invites the advocates, judges, NGOs, academicians of eminence to deliver lectures on current issues. Various e-learning resources such as Westlaw, Manu Patra, Heinonline, JSTOR, Corporate Law Adviser etc. have been made available for their Extensive Use. These resources can be accessed by the students from suitable places in the campus through Wi-Fi facility provided to them. The teaching and training approach is student centric and participative. The students also organise debates, moot court, communication skill programs, sports, career counselling etc with the help of teachers. Students also suggest some new practices which get exposure in the other universities.

The University has made good investment in acquiring and building IT infrastructure by facilitating computers to each faculty with internet connection and access to online legal repositories like Westlaw, JSTOR, Heinonline, CLA and Manupatra. Faculty members of the university are well versed in using computers and computer-based technology. The university, after holding a meeting of faculty members presided over by Hon'ble Vice Chancellor, has decided to designate a group among the faculty to monitor the trends and issues regarding developments in open-source community and integrate its benefits in the university's educational processes. The students are provided with 24x7 wi-fi facility, library facility, and other e-learning resources (Westlaw, Manupatra etc.) which help them in learning beyond classroom. Faculties also resides in the campus and thus the students are free to interact with them whenever required. They also remain in contact with the faculties through emails and other mobile technologies to solve their

various issues. This truly makes the CNLU campus a 24x7 learning facility beyond classrooms. The university has faculty advisor for academic and personal guidance of the students. Several students have benefited from such advisory and personal guidance. The result is visible in moot court and debating competitions won by them. Yes. Faculty members interact with the students regarding current issues pertaining to their subject in terms of provisions and case laws. Power Point and slide presentation are used as innovative method besides group discussion and personal interaction which has fruitful impact in moot court and debating competition. The faculty provide online resources available on the web as well as their own input.

The University has adopted the policy of continuous evaluation process of its students and with that objective the Mid Semester Examination, Project Report writing along with its presentation and End Semester Examinations are conducted, and results thereof are published on time adhering to the academic calendar duly notified on University website before the commencement of academic activities every semester.

The University has the policy of centralised evaluation. The answer sheets are duly coded and then handed over to the examiner for centralised evaluation. Once evaluated by the examiner, the answer sheets are decoded and then the marks are manually fed into the computer system. The Mid Semester evaluated answer sheets are shown to the students by the concerned subject teacher along with his valuable comments and observations. Students desirous to see their evaluated answer sheets of End Semester are shown their answer sheets free of cost upon his/her application for the same. At the beginning of every semester the examination section invites application from the students who want to see their evaluated answer sheets of the preceding End Semester. The University provides the opportunity for re-evaluation of the End Semester answer sheets, as well, to its students. The examination section of the University issues notices in this regard at the beginning of every Semester and thereby invites application from the students who seek re-evaluation of the preceding End Semester's answer sheets.

At present the examination work is done manually, using computers. Coding and de-coding of the answer sheets, feeding of the marks of the Mid-Semester, Project Report, Presentation, Attendance and End-Semester is done manually using the licensed software such as MS-Excel installed on the computer systems in the examination section. The Grade in the respective subjects is prepared by the examination section, and the marks along with the grades are checked and verified by the respective subject teacher. Thereafter, the semester wise Grade sheet is prepared by the Examination section and marks as well as grade sheet are put on the University website.

The communication skill and legal language is essential part of the profession which is taught in the first semester. These exercises sharpen the mind of the students and they learn the skill of lawyering. The internship training in NGOs corporates, law firms, banks and insurance sector, public sector etc opens the scope of legal education. This is the reason that almost all students get opportunity and selection in judicial services, Bank and Insurance, public and private sector-legal advisor, litigation etc. Those who prefer Post graduation education migrate to other law schools in India or abroad, pursue research or Academic job. In this way the course out come is general and specific both as making of a lawyer or academician or researcher. The doctoral program is inter-disciplinary, multi-disciplinary on current burning issues. The hundred percent engagement of the doctoral candidates proves course structure and quality outcome.

The University has three storey magnificent library building with around 20000 books in shelf, journal and magzine, common reacing hall, server room, plagiarism checking cell, xerox cell etc The library building (Nishant Nilayam) has one moot court hall were student practice mooting. It is equipt with all modern facilities. The Library has adiquete number of computers for official as well as students. how ever all student have there own laptops. There is wi-fi facilities, 24*7 electricity and other facility are available. The library fuction even on holidays. The Library has reference books e-journals also. The campus has two hostels-each boys and girls. They are encouraged to learn and earn academic excellence. CNLU has 32 full time teachers and two visiting advocates. All are contributing to the academics with all sincerity, and as per the professional requirement. The faculty members reside in the campus from nine in the morning till late evening. The most important part of the academics is research, which in the name of project, is compulsory. The students have to do research on contemporary issues. The coomunication skill workshop, debate, moot all are to making a confident lawyers. In-door game facilities like carom, chess, and table- tennis are available in the hostels along with badminton courts. The Academic Block has Classrooms, Moot Court Rooms, Lecture Hall, and Faculty Rooms etc. The Administrative Block has offices of the Vice-Chancellor, the Registrar, University Offices, Library with Photostat, and Binding Rooms, University Accounts & Finance office, Security personnel office, Engineering Section, Student affair section, Examination department and Round table meeting room all air conditioned. Parking area for University authorities and visitors is available in the basement of Administrative block. Classrooms are spacious with adequate seating arrangements, white board, and Public address system with Podium installed in every classroom. IT FACILITIES and internet services are available with secured Firewall cum UTM device namely FORTINET. Wi-Fi facility is available in in all blocks and buildings. The CNLU has constructed a spacious moot court hall 200 sitting capacity in the

library premises. Drinking water with Aqua guard is available in all buildings. Proper hygiene and sanitation are maintained by 24-hour housekeeping service. There are round the clock security guards for hostel, offices, and campus security. Hostel rooms with single and double occupancy, well furnished with beds, study tables with books shelves & drawer, study chairs, etc. Care is taken of differently abled students. Hostels have common-rooms equipped with Table-Tennis Boards, Televisions, Carom Boards etc. Gymnasium facilities are available in both halls of residence. The University has guest houses-GANGA accommodates VIPs, Visiting Faculty, Seminar Resource person and other eminent persons. The second guest house -NARMADA provides temporarily accommodation for resident scholars, researchers, Research Associates. The Estate officer of the university is discharging the duties of maintaining and utilizing all support facilities in association with a maintenance engineer. Under the campus development projects, which include levelling field, Landscaping, Construction of parking, drainages, Electrical cabling, Modification Electric Sub Station, Grill works & concertina wire work for safety, Maintenance of roads inside campus etc have been maintained. The University has Engineering section, which maintains the infrastructure facilities of CNLU Campus through outsource.

The campus has Academic Blocks, Administrative Building, Library, Quarter Type I, II, III, Guest House, VIP Guest House, Girls & Boys Hostel, Moot Court Hall.; 70,000 Litres water storage & underground water tank and one Lac litters overhead water tank.; Kota stone, Marble, Granite, Vitrified Tiles, Mosaic Tiles etc. used for floor. Each class room has false ceiling in order to maintain the coding and also to help in the use of Public Address System. All Classrooms, Library, Administrative Sections, Faculties Chamber are Air Conditioned. Gym Facility, Geyser facility is available in Boys Hostel & Girls Hostel. Water purifier with water cooler facility is available in all buildings. Campus is fully equipped with Fire Protection/ Fire Sprinkler. Plantation of more than -1500 trees (Palm, Peepal, Fruit tree, Golden Palm, Cactus, Indian trees, Tikoma, Different types of Flower Plant etc.) and green lawn inside the CNLU campus.

The Estate officers looks after the infrastructure and furniture too. Every year budget is allocated for the maintenance as well as purchase of new furniture and other equipment's. The campus infrastructure, cleanliness, denting-painting, internet maintenance, gardening, repairing of computer etc.is maintained properly – By the regular as well as outsourced staff. The academic blocks have 15 classrooms, moot court hall and teachers' chambers for each teacher. Each classroom is equipped with PA system. Each classroom

It publishes periodicals, treatises, study books, reports, journals and other literature on all subjects relating to law. It promotes legal awareness for achieving social and economic justice for all. It is undertaking research and training projects in law, legislation and judicial institutions. It has been producing law graduates- a social assets, not only to earn from the profession but to render services to society. To create leadership quality for the protection and promotion of human rights and social justice.

CNLU is producing law graduates and skilled legal professional through systemic teaching, training in advocacy and internship in present legal regime in law and social sciences. The moot training and internship and research writing are the regular features of the curriculum for developing practical skill. The students are imparted training in social issues through NSS, holding street plays, legal aid, community awareness and medical check-up camps. It is the result of the missionary teaching and learning in CNLU that many students have been admitted in LL.M courses in U.K, U.S.A., Singapore. The recruitment in law firm/companies, judicial services and Academics in the states of India, are recurring achievements of CNLU.

In order to achieve the vision and mission, the University Academics and Administration is divided into various committees in which students and teachers both are the members. This is the proof of decentralisation and participative management. All the committee are duty bound to organise, manage, and monitor the activities. Each committee is independent and responsible for the assigned task. They are collectively monitored by the Registrar. The academic and debating committee looks in to curricular and extracurricular activities, i.e. classroom activities and organising debates. The Moot court committee looks after mooting activity in coordination with academic and debating committee. Likewise, the library committee is responsible for teaching and learning activities. The Cultural committee organizes classical, literary and Fest (Jivatva) programs for personality development. The Sport committee looks after Indoor and outdoor sport activities. By University collaboration with research institutions, it is sharing and disseminating knowledge It has been producing law graduates- a social assets, not only to earn from the profession but to render services to society. The Vice-Chancellor is the head of Institution. The University is governed under apex Governing Body, i.e. General Council, Finance committee, Academic council, and Executive council. The Registrar works as the Principal Adjunct to Vice-Chancellor. The University Administration is divided into various committees in which students and teachers both are the members. There is participative management in the University. All the committee are duty bound to organise, manage, and monitor the activities. Each committee is independent and responsible for the assigned task. They are collectively monitored by the Registrar. The academic and debating committee organises curricular and extracurricular activities, i.e. classroom activities and organising debates. All these prove that CNLU administration is decentralised and participative.

6.2 Strategy Development and Deployment

6.2.1 The institutional Strategic plan is effectively deployed.

Response:

CNLU runs BA.LL.B. (Hons) and BBA.LL.B. (Hons) courses. The review of the Curriculum/syllabus of the Courses has been done for UG PG both. The new subjects as electives/optional have been introduced in BA.LL.B. BBA.LL.B. Courses. In 2018-19 session, the Hons papers have been specified. In LL.M., four specialisations courses –constitutional law and corporate law, Criminal law and IPR have been introduced. The subject teachers are authorized to develop their course structure according to BCI UGC and Industrial /corporate requirements and reviewed by curriculum committee. On approval of the Academic Council, it is notified to the students. The students are imparted theoretical courses in the classroom, and practical courses, i.e. Moot court, Arbitration practices, Pleading drafting and conveyancing, arbitration, legal aid clinic. The Students undergo internship with NGOs, Law Firm, Advocates and Hon'ble Judges. The Teaching is based on student centric, participative, experimental, and problem solving. The Mode of teaching is discussion, seminar, lecture, and problem solving.

The purpose of examinations is to assess the students through Mid Semester and End Semester examination. CNLU practices internal question setting and evaluation system by the teacher who teaches the subject on teacher evaluator principle. The mode of question is short, long, and application based. The copies are coded immediately and handed over to the concern teachers and evaluated within fortnight. It is shown to the students after decoding them. The project work is the part of curriculum and examination process. The marks are divided in written project and viva-Voce. The students Grade sheet is prepared annually, in B, B+, A, A+, D O. The result is uploaded on the website every semester.

CNLU imparts research oriented education to the undergraduate and post graduate students in terms of research project and Dissertation, respectively. This is meant to inculcate creativity among them. CNLU imparts doctoral programs: Ph.D. in law, social sciences with law, Ph.D. in sciences with law, Ph.D. in humanities & social sciences (from 2021 session), D.Phil.-General and LL.D. CNLU library has more than 20000 books on various subjects of law and social sciences. It subscribes Journals National and International, Magazines and Various newspapers in English as well as Hindi. KOHA, the Integrated Library Management Software is being used for different housekeeping operations of library (version 3.08 of 2012). Library subscribes various E-resources, that are- SCC Online, AIR Database, Lexis India, WestLaw, HeinOnline, Manupatra, JSTOR, CLAOnline, Economic and Political Weekly, and Bar Bench, with remote excess facility. CNLU has good Human resource organisation and management system under the supervision of the vice-chancellor, registrar, administrative officer, and academic coordinator for managing teaching and Non-Teaching staff. The executive council is the final authority of the university to regulate all the activities of the staff. The Staff orientation programme is conducted every three months in the university to motivate the staff for punctuality, regularity, sincerity, Inter-personal relationship.

6.2.2 The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules and procedures, etc.

Response:

The General Council, the Executive Council, The Academic Council, The Academic Planning Board and the Finance committee are the policy making bodies. The Vice Chancellor, the Registrar, the Deans, the Heads of the Dept., Such other officer as may be prescribed by the statute are executive bodies. The Chief Justice of the Patna High Court is the ex-officio Chancellor of the University. The General Council of the university is the plenary authority of the university which is empowered to formulate and review the broad policies, and programmes of the university and devise measures for the improvement and development of the university. The Executive council is the chief executive authority of the university and is empowered to administer the university in accordance with the provisions of the university Act and the statutes and regulations made there under. The Academic Council is entrusted with the management of academic affairs of the university. The Academic Planning Board develops plans of the future programs of the university. The Finance Committee is empowered to examine and scrutinize the annual budget and to make recommendations on all financial matters to the Executive Council

CNLU has been established to impart interdisciplinary, multidisciplinary, and cross disciplinary legal education. Hence to cope with the required speed to achieve the target, e-governance is a tool, adopted by the institution. The University is planning to adopt the guidelines of NAAC and all the items under AQAR. The CNLU Website and MIS system are under consideration for improvement. The Faculty development program is the important aspect of planning.

The administrative activities in CNLU, is decentralised ,cooperative and collective. The vice-chancellor, Registrar, Deans, heads of Committees, collectively control and regulate the activities. All the teachers have assigned administrative task along with teaching and research. The ICT tools -- internetservices, printers, fax, telephone, are used for this purpose. The installation of CCTV has made the administration comfortable to control and regulate the employees and students. The finance is highly automated with e-governance. The fee is online- paid. Almost all financial activities are online. The salary of the employees is online paid into their accounts. Almost all the receipt is on-line whereas payment is done through check as well as on-line.

The vice-Chancellor is the appointment authority on the recommendation of the selection committee duly constituted as per UGC and Bihar Government. Teacher's Service rules are as per the UGC guidelines, whereas the non-teaching staff are governed by Bihar Government Rules. The code of conduct is well defined and all the procedures and principles of natural justice are followed before taking any action. The executive council (EC) is the final authority is the final body for appointment, promotion, assignment of task etc. The decision of EC is final. The chancellor is the appellate authority.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has a performance appraisal system, promotional avenues and effective welfare measures for teaching and non-teaching staff.

Response:

CNLU follows the policy of grooming faculty members through workshop, orientation program, teaching methodology and research workshop, orientation program on specific subjects, workshop on question setting evaluation and communication skill etc. The faculty members' performance are appraised regularly in the class where in the vice-Chancellor /senior professors sit and listen. They analyse the impact and discuss with the teacher off the class, suggest measures to improve. In the faculty meetings, the class progress is discussed along with teachers progress is assessed and support is provided as per required need. At the end of each semester exam, the student fill up structured feedback form which are discussed among the faculty by the registrar and vice-chancellor. Again the faculty is called and matter is discussed for improvement. Every year, the faculty has to submit report on academic achievements—Seminar, training, workshop, FDP, research publications etc. It is presented in the General Council wherein Hon'ble chancellor appraise each teachers performance .CNLU does not follow the API based performance appraisal which is just paper appraisal. CNLU appraises on the floor and motivates for improvement. There is no API appraisal system for the Nonteaching staff also. Their performance is appraised through the Administrative office by punctuality,

regularity, disposal of work, obedience/loyalty, proactive attitude, efficiency and cooperative attitude. All these arte noted by the Administrative officer and discussed in the quarterly staff orientation program. Any negative points are dealt with motivational approach. The faculty has got promotional avenue through CAS under UGC scheme. The process of promotional screening is as per UGC guidelines. It is continuous process. The promotional policy for non-teaching staff is also available. The University has adopted welfare schemes for teaching and non-teaching staff: EPF, medical, gratuity, maternity benefit, medical leave, earn leave, residential facility in the campus etc.

6.4 Financial Management and Resource Mobilization

6.4.1 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Response:

The University has been established by the Act of 2006 of government of Bihar. The government has provided 18 acres of land, borne infrastructure construction etc. The university has been collecting fee from students and has a very sufficient corpus. The government provides repairing and maintenance fund. The university garners resources from UGC, UNICEF, various corporate bodies etc. CNLU mobilises projects funds from government of India, Bihar government, endowment fund from public for different medals for students. The university utilises its fund in various renovation and construction activities.

The university has a full time finance officer, Account Officer and regular audit is conducted to monitor effective and efficient use of financial resources. Committees have also been formed to ensure proper use of the resources. The university has mechanism for internal audit. The annual finances are audited by a qualified chartered Accountant scrutinized by the Finance Committee and approved by the Executive Council which in turn is presented to the General Council for its final approval. The university has sent a formal request to the Auditor General Bihar Circle for External Audit. The university has constituted Finance Committee having the Vice-Chancellor, Registrar, Commissioner cum Secretary Education and two other members nominated by the executive council. The Finance Committee examines and scrutinizes the annual budged, considers any proposal for new expenses, re-appropriation and audit reports and offers its recommendations to the Executive Council. The meeting of the committee takes place at least once in three months. They are audited regularly every year. There are no major audit objections. Being a statutory University, the University is partly funded by the State and the UGC. The Panchayati Raj chair has been instituted under the sponsorship of the government of Bihar. University is in process of approaching funding bodies for the establishment of another chair on IPR. The University is attracting some endowment funds from the general public.

The cell has been encouraging the faculty to write research papers ,participate in the seminars,undergo orientation /refresher courses, FDP charing sessions, delivering extra lectures at different academic institutions. 6.5.3 Incremental improvements made for the preceding five years with regard to quality (in case of first cycle), Post accreditation quality initiatives (second and subsequent cycles).

Response:

The IQAC has been constituted on 15th June 2015, just before the first cycle visit of NAAC. The report of the NAAC was encouraging. The IQAC got functional gradually along with the administrative structure and pattern. Since the legal education is research oriented, therefore, IQAC took the initiative of 'Research Oriented Teaching workshop' in the post accreditation cycle. Here in the faculty members were guided how to prepare lecture plan, case study, framing of question for class discussion, raising issues for debate in the class with reference to current legal issues relevant to the lectures. This program has been recurring every semester Meeting of all Committees. IQAC has initiated inhouse debate on legal issues. It has been orienting the mind of students and faculty both. IQAC also took up the challenge of coordination of the various committee Meetings of all committees in CNLU. This helped committee to learn the problems of each other. It has been found that conflict is a very common phenomenon, since each human being has his own interest which propels their emotions, may lead to major conflict. The workshop on emotional intelligence has been working magical effect on the teaching as well as non-teaching staff. The Staff Orientation Program (SOP) has become very popular in CNLU. Here the staff has been given to freedom for sharing their grievances. This diffuses tension and the root cause of conflict is reduced. Inter-personal conflict resolution

Teacher's orientation program (TOP) is organised separately in which all the aspects of teaching and research are discussed.

IQAC initiated training in mock interview for the students who had qualified mains examination of various state judicial service examinations. To achieve optimum rate of success many judges and noted academicians were called by the university who through expertise and great experience paved the path of success for the participants. This initiative yielded excellent result and most of the participants got finally

This exercise helped the students immensely in overcoming their sense of fear and equipped them with sound fundamental knowledge to meet the interview Board. University looks forward to carry on with similar initiatives for other prestigious competitive examinations in future too.

CNLU is a national Law university where admission is allowed through CLAT test with all India entrance test. Therefore, students from different region, religion, caste, language culture come and reside in the campus in the halls of residence. The mode of instruction in CNLU is English only. This reduces the linguistic problem. Since all are law students therefore, they have a sense of Indianness prevalent as per the preamble of our constitution. They have rational thought and modern outlook hence they do not believe in gender and cultural differences. This helps the university administration in augmenting the sense of fraternity among students very easily. The Senior students are part of anti-ragging squads along with security officer, warden (Halls of Residence) and faculty members. The freshers are informed about the issues pertaining to ragging and the mechanism evolved by the university administration to handle such incidents strictly in accordance with the zero-tolerance policy of the UGC. Further the senior students also apprise them about the campus scenario and how best they can utilise their time effectively by being part of the various campus activities. The university organises an orientation programme every year on the first day of the academic session for the new students. In this programme most of the faculties along with the vice chancellor interact with the students and inform them about the importance of law as a profession. They are sensitized about the prospects of law and its growing avenues. The university administration also endeavours to alleviate the fear of ragging on any ground -linguistic, cultural, sex, regional or communal. CNLU encourages dialogue on such issues and creates and environment of harmony by encouraging a formal dialogue between the senior and the junior students.

(Hons.) and B.B.A., LL.B., (Hons.) courses. The university continuously endeavours to enhance and augment the research skills interfacing with the science and technology. The University believes that mentors must be given importance in drafting and implementing of the curriculum of the university. They are well aware of various needs of the learners and can accordingly contribute substantially to their academic growth. The teachers teach the Law subjects in the social context and social sciences in the context of law thereby injecting interdisciplinary and holistic thinking about the subject in its proper context. Teachers through their teaching assignment, question setting and the evaluation of the script make the entire learning drive very fruitful for the students. Since the evaluators are the same, so they are in a better position to filter out strengths as well as weaknesses of the learners. To provide quality legal education in highly globalized and competitive society, interdisciplinary and multidisciplinary research skills in both teachers and taught are indispensable. University is aware of the paramount significance of research activities and worthy publications in various periodical and research journals to give fillip to such activities. Our university has been successfully publishing its own journal that has been cataloguing some of the best articles in this country. 7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

The university has the mechanism to get the feedback of the students at the end of every semester. The feedback is duly analysed and faculty are advised accordingly in periodic faculty meetings. As a result of these measures academic performance of the students has improved significantly. The teachers are regularly guiding them to excel in studies and co-curricular activities. The university is very much concerned about the academic advancement of economically disadvantaged section of the society and thus regularly conducts study on their academic performance. The performance of slow learners and physically handicapped students is also analysed on the basis of their academic activities and other performance indicators. In the study it has been found that the students, who belong to the weaker sections of the society, do lack in the areas of communication, presentation and writing skills. The medium of instruction being English poses a big challenge to them as most of them come from Hindi medium schools. This also has a bearing on their examination results which is reflected in the form of backlog papers and detention. Equal Opportunity Cell puts on extra efforts in ameliorating this situation as 50% of the students fall in this category needing the active involvement of Equal Opportunity Cell. At the end of each semester's examination, students are given a proforma to evaluate the respective faculty members on the basis of various criteria as laid down by the university and furnish their feedback. This data is collected and analysed by the university and concerned faculties are informed about their performances and strengths and weakness. Further, faculty members are, if necessary, advised to enrich and update their subjects so as to improve the quality of the teaching-learning process.

CNLU since its inception has been committed to provide that knowledge which is holistic and wholesome and leads to enlightenment and liberation of mind .CNLU has been producing best legal minds in the country who have brought much pride to the university by their exemplary performance in all professions be it advocacy, corporate world and NGO. In addition to these feats students have earned appreciations from different judges of high courts and supreme courts by working as court clerks in different high courts and Supreme Court of India. CNLU students wherever they have worked have earned great respect for themselves and have brought great laurels for the university. CNLU students with ample support from the administration under able guidance of teachers have always tried to achieve best in their life without compromising ethical primer of life. CNLU has been consistently striving to spawn and propagate further great ideals of legendary Chanakya in whose name the university is established.

The CNLU Legal Aid Society has been working for providing legal aid as well as increasing awareness. In addition to this every year students hold CNLU parliamentary Debate in which teams from reputed university participate. In course of years since its inception parliamentary Debate competition has emerged as the most sought for event not only in the state of Bihar but in the whole country. Parliamentary Debate had got even international participation in one of PD edition. Debating has been something that has been uniting the students like an unbreakable bond has brought great laurel to the university in past few years.
