ORDER

- Instant complaint u/s 355 BNS has been presented before this Court by Ld. APP in presence of I/O. Accused also present. Perusal of file reveals that on 18.03.2025 Police of Police Station Bhaderwah while patrolling found accused namely Bikram Singh S/o Mahinder Singh R/o Gandoh Distt. Doda creating public nuisance near Nalthi Naka, Tehsil Bhaderwah in an intoxicated state.
- Advocate, Majid Malik appeared on behalf of the accused and also filed Vakaltnama. The same
 is taken on record. At this stage, Ld. Counsel for the accused also filed an application for
 confession of guilt of on behalf of accused.
- 3. The accused was separately informed in open Court that he is not bound to make the confession and was also made aware about the probable consequences of the confession and was provided time for thinking over, but the accused, after some time again reiterated that that he wants to confess his guilt and is voluntarily making the confession.
- 4. The plea of the guilt of the accused is recorded in the open court; same is read over to the accused. The accused admits the same as true and correct.
- 5. In my considered opinion, the accused has confessed voluntarily and is not under any threat, promise or undue influence.

UT v/s Bikram Singh

Accordingly accused is convicted and is sentenced to undergo Community Service of cleaning at Shri Gomata Seva Samiti Dhamunder Bhaderwah for 03 days with effect from 24.03.2025 to 26.03.2025 daily for 03 hours from 11:00 AM to 02:00 PM. The convict will complete his sentence under the supervision of SHO P/S Bhaderwah who will file the compliance report as well as few photographs of accused performing community service before this Court after completion of sentence. Put up on 03.04.2025 for filing of compliance report.
