ORDER

Heard Mr.Angels Nair, Petitioner-in-person and Mr.T.P.Sajan, learned Special Government Pleader.

2. The Petitioner-in-person has raised an issue regarding a Malayalam entertainment commercial film shooting in a reserved forest in Kasargod in the year 2018. According to the Petitioner, substantial damage was caused in connection with the movie set.

3. In response to the petition, a counter affidavit is filed by the Under Secretary to the Government, Forest & Wildlife Department, wherein a Government Order dated 30 March 2013 is annexed. This Government Order is issued by the Forest & Wildlife Department in respect of revision of entry fees and security deposits in national parks, wildlife sanctuaries, tiger reserves and other protected areas in the State. In the said order, a table is reproduced, specifying the fees for commercial films. Documentary/educational films are treated separately.

4. The question raised in this petition is whether a permission for commercial films would be desirable in the national parks, wildlife sanctuaries and tiger reserves and also whether the State has formulated any

policy in this matter apart from fixing the rates, as indicated in the documents.

5. The learned Special Government Pleader seeks time to take instructions in this regard.

6. We appoint Adv.Mr.Manu Vyasam Peter as Amicus Curiae to assist the Court. The Registry will furnish all the necessary papers to the learned Amicus Curiae.
