**UPON hearing the counsel
the Court made the following
O R D E R**

1) The instant special leave
petition was filed on 16th August,
2025, along with an application
seeking permission to file special
leave petition without certified copy
as well as plain copy of the order
impugned, indicating that the order

dated 31.07.2025 has not been uploaded on the website of the High Court of Punjab and Haryana.

2) The special leave petition came for consideration on 20th August, 2025; however, considering that the order of rejection of anticipatory bail has not been uploaded up to 20th day, we sought a report from the Registrar General of the High Court of Punjab and Haryana, which is attached to the file.

3) From the report, the following facts appear:

(a) The order impugned was of 31st July, 2025, and up to 20th August, 2025, it was not uploaded.

(b) The Registrar General sought

explanation after two days, on 22.08.2025, from the Secretary of the Hon'ble Judge.

(c) The Secretary responded on 22.08.2025, but the Registrar General sent a report on 25.08.2025.

(d) As such, immediate action in the matter to report at the earliest, was not taken.

(e) Mr. Sham Sunder, Secretary, has not replied when the order was uploaded except to say that the Hon'ble Judge was undergoing some medical procedure and surgery between 01.08.2025 to 20.08.2025.

(f) On the date of submitting

the explanation by Secretary, the order was uploaded; however, this fact was mentioned by him.

(g) It appears that order impugned was not passed on 31st July, 2025, in fact, it was passed after the order by this Court.

4) However, the steno book of the Secretary be seized and it be find out on which date the order was typed and corrected on P.C.. The discreet inquiry be held and the report of P.C., from NIC be collected regarding typing and uploading and the same be filed on affidavit.

5) Issue notice.

6) Mr. Shashank Shekhar, Advocate

on Record, appears for respondent No.3-complainant, however, service on the complainant is waived.

7) Notice be issued to the respondent-State, returnable in four weeks.

8) In the meantime, by way of interim recourse, it is directed that subject to cooperation of the petitioner in the investigation, no coercive steps shall be taken against him in connection with FIR No.155 of 2025 dated 06.05.2025 registered at Police Station Dabua, Faridabad, Haryana.
