**CIRCULAR**

Today, a meeting of office bearers of Coordination Committee of all District Bar Associations of Delhi took place at Patiala House Court on the ongoing issue regarding recording of evidence of police officials from the police stations.

**We firmly stand on our demand and reiterate that police personnel have to appear only in physical mode in the courts for the purpose of deposition/evidence.**

Today, a communication has been received from the Chairman, Bar Council of India, addressed to the Presidents/ Secretaries of all District Courts Bar Associations of Delhi to recall the ongoing agitation. However, we would like to make it crystal clear that the Coordination Committee has raised the agitation to protect the interest of public at large and will continue with the agitation till our genuine demand is not met with.

**It has been unanimously resolved that if, our above-mentioned genuine demand that all the police officials have to appear physically before the court for deposition/ evidence which is in the benefit of public at large for the purpose of fair and free trial, is not acceded to, we shall continue with our call for indefinite abstention from work w.e.f. 08.09.2025 and the same shall be in more intensified manner.**
