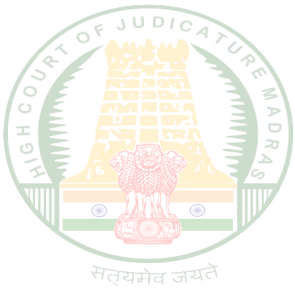

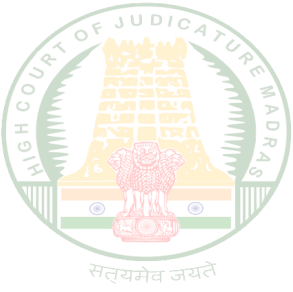

2. Petition is dismissed for non-prosecution. Consequently, the interim applications are also dismissed.

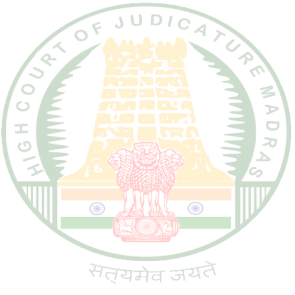
