

THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 31.10.2025, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:



# **JUDGMENT**

The Writ petition is filed with the following prayers:-

- i) Issue a writ of mandamus directing the respondents to protect the petitioner by issuing a certificate of vending (Protection of Livelihood and Regulation of street vending Act 2014) and permit to do street vending near Thamarassery Civil Station within the area of 2<sup>nd</sup> respondent.
- ii) Issue a writ of mandamus directing the  $2^{nd}$  respondent to implement Exhibit P4 Rules framed by the government to protect the street venders within the area of the  $2^{nd}$  respondent Panchayath.
- iii) Issue a writ of mandamus directing the 2<sup>nd</sup> respondent to implement exhibit P5 scheme framed by the Government to protect the street vendors within the area of the 2<sup>nd</sup> respondent Panchayath.



- iv) Issue a writ of order or direction directing the 3<sup>rd</sup> respondent to issue vending certificate to the petitioner as per Section 4 of the Street Vendors Act 2014 to do street vending without causing any nuisance and hindrance to the public, or pedestrians or to the traffic near Thamarassery Civil Station.
- v) grant such other relief as this Hon"ble court may deem fit and proper in the facts and circumstances of the case including to dispense the translation of vernacular documents/ Exhibits.
- 2. A counter affidavit has been filed on behalf of the local authority, specifically contending that the Street Vendors Act and the Rules made thereunder do not apply to the respondent-Grama Panchayat. Section 2(c) of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act defines a 'Local Authority', and it is the contention that the Act itself would not apply in the area in question. It is also stated that the writ petitioner has been occupying National Highway 766 from Kozhikode to Kollagal, in the busiest stretch of Thamarassery

Bazaar, causing terrible traffic congestion, leading to frequent complaints from the public.

- 3. Accordingly, through Exts.R3(a) and R3(b), the Grama Panchayat decided to remove the illegal occupation. Thereafter, an additional counter was filed alleging that the petitioner is a native of Kannur District and had migrated to Kattippara Grama Panchayat a few years ago. It is stated that he had erected an illegal temporary structure encroaching on National Highway 766, thereby obstructing motor traffic and the pedestrians using the footpath. Exhibit R3(d) photographs are also produced, along with the counter affidavit.
- 4. A statement has been filed on behalf of the Government contending that the Grama Panchayat would not fall within the definition of the 'Local Authority' for the purpose of the Act or the Rules, and also relies on the judgment of this Court in Sajjad and Others v. State of Kerala and Others [2018 KHC 804].
- 5. It is not in dispute that the area in question is a Grama Panchayat. The allegation of the Panchayat is that the petitioner

has encroached on the National Highway.

- 6. Learned counsel for the petitioner would argue that the definition of 'Local Authority' under the Act includes such other body entitled to function as a local authority in any city or town to provide civic services and regulate street vending, and includes the "planning authority" which regulates the land use in that city or town. He also relies on the definitions in Article 243P and 243Q of the Constitution of India.
- 7. Since there is no dispute that the area in question is a Grama Panchayat, as held by this Court in **Sajjad** (supra) it does not fulfil the definition of a 'Local Authority' within the meaning of Section 2(1)(c) of the Street Vendors Act, inasmuch as it is not a local authority functioning in an urban area. The petitioner has to fall within the ambit of the Act to get any protection under the Act.
- 8. Under such circumstances, the Act has no application and therefore, the prayers sought for in the Writ petition cannot be granted.




9. However, if the petitioner makes an application for conducting trading in a mobile cart without obstructing the traffic or pedestrians, the same shall be considered by the Panchayat in accordance with law and an appropriate decision taken.

The Writ petition is disposed of as above.
