The One-Year Regular LL.M. programme at Dhirubhai Ambani University – School of Law is carefully designed to meet the evolving needs of legal professionals in India and beyond. This rigorous, academic programme combines in-person classes, structured research assignments, and a mandatory international research tour to offer a well-rounded learning experience. By addressing emerging market demands, the programme bridges important gaps in India's LL.M. offerings and prepares graduates to navigate complex legal challenges at both national and global levels.

Spread over three trimesters within one year, the programme is tailored for working legal professionals including advocates, in-house counsel, judicial aspirants, and recent law graduates. The curriculum balances core courses, specialised electives, and a dissertation, all supplemented by substantial research components that enhance critical thinking and analytical abilities. A key feature is the international research tour, which expands students' perspectives through exposure to comparative legal systems and global best practices.

The programme offers five focused streams that align with India's development priorities and global trends: ESG, Carbon Markets and Sustainability; Aviation Law; AI, Data Protection and Technology Law; Construction Law, Contracts and Arbitration; and Judicial Administration and Justice. About the LL.M. in Aviation Law

Air travel has become an integral part of modern life, connecting people, businesses, and economies worldwide. India is the third-largest aviation market, handling over 350 million passengers annually and supporting more than 7.7 million jobs, with expectations to become the largest market in the coming decade. This rapid growth, combined with global challenges such as passenger rights, aircraft leasing and financing, aviation safety and liability, cybersecurity, climate responsibilities, and operational complexities, has created a strong demand for legal professionals who understand both the regulatory and commercial dimensions of aviation.

A distinctive feature of the programme is its industry engagement. Experts from aircraft manufacturers, OEMs, airlines, regulators, and airport operators share insights on current practices, emerging trends, and operational realities, giving students a practical understanding of the sector. The curriculum is structured across three trimesters. The first covers the aviation ecosystem, international air law, domestic regulations, aerospace management, contracts, and aircraft leasing and financing. The second focuses on safety, along with specialised modules tailored to industry needs, including aircraft and UAVs, airports, and ground handling. The final trimester concludes with a dissertation or capstone project, supported by optional internships at airlines, airports, regulatory authorities, or law firms.

Graduates of the programme are well-prepared for careers with aviation practices in law firms, regulatory and compliance teams, commercial operations, dispute resolution, policymaking, and aerospace management. With its blend of legal training, industry exposure, and practical skill-building, the LL.M. in Aviation Law equips students to thrive in a rapidly growing and evolving sector.



Course Structure



Trimester 1

- Research Methodology (3 credits)
- Global Aerospace Legal Framework (2 credits)
- Aviation Economics, Strategy, and Management (2 credits)
- Aviation Contracts, Leasing, and Financing (2 credits)
- Optional apprenticeships or internships with manufacturers, OEMs, airlines, regulators, or law firms with aviation practice.



Trimester 2

- Law and Justice in a Globalised World (3 credits)
- Aviation Security, Safety and Liability (2 credits)
- Aircraft and Unmanned Aerial Vehicle (UAV) (2 credits)
- Airports and Ground Handling Operations (2 credits)
- Mandatory International Research Tour and report (2 credits)
- Optional apprenticeships or internships with manufacturers, OEMs, airlines, regulators, or law firms with aviation practice.



Trimester 3

- Comparative Public Law (3 credits)
- Dissertation / Capstone Project (5 credits) with supervised research
- Optional apprenticeships or internships with manufacturers, OEMs, airlines, regulators, or law firms with aviation practice.

Teaching Methodologies

The LLM. in Aviation Law combines classroom learning with direct exposure to the aviation industry. Lectures and discussions provide a solid grounding in air law, regulatory frameworks, and commercial aspects. Case studies based on aviation safety issues, and regulatory disputes, developments help students apply concepts to real situations. Simulations such ลร contract negotiations and compliance exercises offer practical experience with sector-specific challenges. Policy round tables with airlines, regulators, manufacturers, and airport operators give students an opportunity to engage with current industry debates. Workshops, internships, and other experiential learning avenues link academic study to professional practice, while research projects develop critical thinking and subject expertise.

International Research Tour

As a mandatory component of Trimester 2, the International Research Tour provides 1–2 weeks of immersive global exposure. Students will visit aircraft manufacturer's Final Assembly Line and engage with international aviation regulators and key legal institutions to explore regulatory frameworks, compliance standards, and operational practices worldwide. This experience deepens their understanding of international aviation law and prepares them to address complex cross-border legal challenges in aircraft operations, safety, and aviation policy.

Ph.D. in Law

The School of Law at Dhirubhai Ambani University has launched its doctoral programme in law with a focus on advanced interdisciplinary research and contemporary legal challenges. The programme received an overwhelming response, with over 100 applications in its inaugural cycle. After a rigorous selection process, five candidates were admitted.



The selected cohort includes:

- Part-time scholars: Two specializing in AI, Data Protection and Technology Law.
- Full-time scholars: One each in ESG, Carbon Markets and Sustainability, AI, Data Protection and Technology Law, and Construction Law, Contracts and Arbitration.

This reflects the Law School's emphasis on cutting-edge areas of law, fostering both academic scholarship and applied legal research.
