**Subject: Misleading and Illegal advertising, offering assurance for Trade Marks protection through online registration by various online service providers.**

This office has taken serious note of certain entities engaging in advertising and solicitation of prospective applicants or client of other attorneys/ agents offering legal services through various digital and online platforms. Such activities are in direct contravention of the provisions of the Advocates Act, 1961 and the rules made thereunder, which strictly prohibit advocates and legal agents from soliciting or advertising legal services.

It has further come to the notice of this office through various sources that the entities including as given hereunder are advertising themselves and reaching out to the stakeholders to help them register their trade mark (brand name, logo, slogan, icon, etc.) from anywhere in India through their online registration services:
