Participation Options & Fee Structure

The SILF Law Firm Olympics have been structured to ensure **competitive fairness, flexibility, and clarity**, keeping in mind the team sizes and professional commitments of participating law firms.

With **10 sporting disciplines** forming part of the Olympics, law firms may choose from the following participation options:

Option 1

All Sports Complete Olympic Experience

- Participation across all **10 sporting disciplines**
- Recommended squad size: **35–45 lawyers**
- Eligible for:
 - Overall Medal Tally
 - SILF Olympics Champion Trophy**
 - All individual and team awards

Option 2

All Racquet Sports Participation Focused Multi-Sport Entry

- Participation across all **racquet sports**
- Recommended squad size: **15–25 lawyers**
- Eligible for:
 - Sport-specific medals and trophies
 - Inclusion in overall medal tally
 - Eligibility for **SILF Olympics Champion**, subject to medal performance

Option 3

Single Sport Participation Complete Team Entry for One Sport

- Participation in **any one sport** with a **complete team for that discipline**
- Recommended squad size: **as per sport requirements**
- Eligible for:
 - Sport-specific medals.
 - Inclusion in overall medal tally

Participation Fee:

₹3,00,000 + GST per firm

Participation Fee:

₹2,00,000 + GST per firm

Participation Fee:

₹75,000 + GST per firm

Championship Determination

- The SILF Olympics Champion title will be awarded based on the overall medal tally, with Gold Medals carrying the highest weightage.
- Participation in fewer sports does not restrict eligibility for the championship if medal performance merits the title.
