## ELIGIBILITY

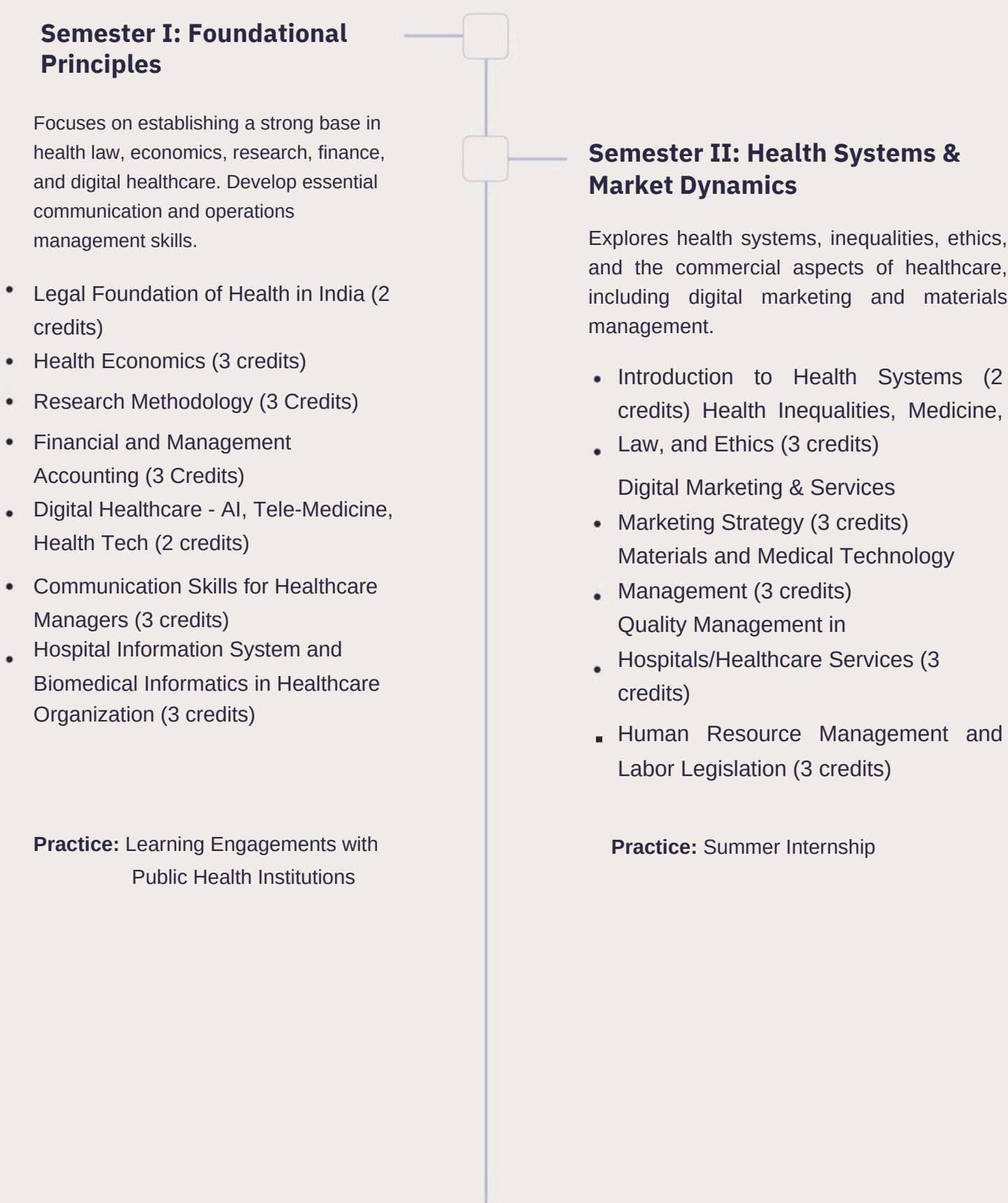
Graduates of all disciplines with a valid Indian or International degree (pursued in English Language) are eligible to pursue this course. Subject areas that will be preferred, but are not mandatory, include law, healthcare, life sciences, medicine, business, and similar allied courses.

A minimum of 50% score must be obtained in the graduate degree (45% for the reserved category).



# Program Structure: An Integrated Approach

The MBA in Healthcare Management and Law offers a unique curriculum structured over four semesters, integrating legal education with healthcare management. Each course includes relevant legal aspects for the health sector, complemented by practical learning engagements.





### Semester III: Leadership & Strategic Development

Advances understanding of leadership, data protection, analytics, and strategic planning. Fosters innovation and entrepreneurship in healthcare.
