Recognizing that the true essence of legal education lies in the seamless blend of theory and application, the RCC embarks on its maiden initiative in collaboration with the Chambers of Abhinav Mishra Advocates & Solicitors to introduce a cutting-edge, double-credit course on Drafting of Pleadings before the Hon'ble Supreme Court of India - a course designed to refine advocacy skills and bridge the gap between classroom learning and courtroom reality.



# ABOUT THE COURSE

This Double Credit course has been designed to provide practical exposure to drafting pleadings before the Hon'ble Supreme Court of India, ranging from Writ Petitions to Appeals. The course specifically focuses on imparting training on the essential procedural laws/rules governing effective pleadings under appellate, constitutional and original proceedings. Considering that academic learning often does not entail substantial drafting exposure, despite its centrality to an efficient litigation practice, due emphasis shall be placed on presenting a concise synopsis and sequence of events, narrating the factual matrix relevant to the case at hand in brief, framing questions of law and grounds, and ensuring compliance with the Supreme Court Rules, 2013, including adherence to the professional standards expected of litigators practising before the Hon'ble Apex Court.

Through structured modules, the participants/attendees shall be allowed an opportunity to engage in drafting, inter alia, Civil and Criminal Appeals, Special Leave Petitions, Writ Petitions, Public Interest Litigations, Transfer and Contempt Petitions, including Review and Curative Petitions. Each module shall attempt to integrate doctrinal grounding with hands-on drafting exercises, analysis of filed pleadings, and simulation-based learning, thereby enabling law students and young practitioners to develop court-crafting skills while also gaining a deeper understanding of the Hon'ble Supreme Court's practice and procedures.

He leads high-stakes litigation across diverse legal domains, including White-Collar Crimes, Arbitration, Aviation, Corporate and Commercial Law, Insolvency, Real Estate, Electricity, and Intellectual Property, alongside advising on regulatory compliance in Banking, Finance, M&A, and Taxation.

Renowned for his proficiency in complex legal disputes, Mr Mishra has secured numerous reportable judgments across the Supreme Court, various High Courts, the NCLAT, and NCLT Benches nationwide.
