In today's dynamic legal and business environment, professionals across industries—lawyers, corporate executives, entrepreneurs, and compliance officers—must possess the ability to draft, review, and negotiate contracts with confidence and competence.

This certificate course in Defence and High Technology Contract Drafting is designed to equip participants with the knowledge, skills, and practical tools necessary to draft clear, concise, and legally sound contracts. The course will bridge theoretical legal principles with real-world applications, enabling participants to navigate the complexities of contract law and drafting with proficiency.

## Objectives

The certificate course aims to Provide:

- A comprehensive understanding of the fundamentals of contract law in contexts, which enhances market skills, including offer, acceptance, consideration, and enforceability, and their practical application in drafting, interpreting, and analyzing Defence corporate contracts and High Technology Nuclear Energy Deals.

Equip participants with the ability to analyze Defence and High Technology contracts effectively, including reading and interpreting contractual terms to identify legal risks, obligations, and opportunities.
- Enhance the ability to design effective clauses to mitigate legal risks, ensure regulatory compliance, and align contract terms with legal requirements.
