Writ petition (public interest litigation) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(PIL) the High Court be pleased to

(i) To issue appropriate interim directions to Respondents No.1, 2 and 3 to forthwith take immediate and appropriate measures to ensure that collection, storage, processing and transmission of sensitive personal data of passengers at airports across India is conducted in strict compliance with the provisions of the Digital Personal Data Protection Act, 2023 and the Digital Personal Data Protection Rules, 2025, pending disposal of the present Writ Petition;

(ii) To issue appropriate interim directions to Respondent No.2 to forthwith restrain and prohibit all existing commercial licensees, concessionaires, service providers and intermediaries operating at airports from onward sharing, commercial exploitation or unauthorised disclosure of passengers' personal data to third parties, pending disposal of the present Writ Petition;

(iii) To issue appropriate interim directions to Respondent No.2 to forthwith stay all pending tender processes, requests for proposals and contractual arrangements involving engagement of private parties, concessionaires or service providers for purposes involving collection, storage or processing of passengers' personal data, until comprehensive data protection clauses in compliance with the Digital Personal Data Protection Act, 2023 and the Digital Personal Data Protection Rules, 2025 are incorporated in such tender documents and contractual arrangements, pending disposal of the present Writ Petition.

This petition coming on for admission upon perusing the petition and the affidavit filed in support of WP(PIL) and upon hearing the arguments of SRI.SANTHOSH MATHEW (SR.) along with SRI. JAYASANKAR R., Advocates for the petitioner, SMT. O. M. SHALINA, DEPUTY SOLICITOR GENERAL OF INDIA for the respondents and of SRI. ARJUN VENUGOPAL, CENTRAL GOVERNMENT COUNSEL & ADV. SRI.VENKATESAN KRISHNAMACHARRY, the court passed the following:
