An emergent meeting of the Executive Committee of RCBA was held on 24th March 2026 regarding the brutal attack on the house and family of one of its respected member Adv. Pawan Bhardwaj

In this incident, his brother was shot dead, and his father and nephew suffered bullet injuries. The incident took place on 19th March 2026 and was captured in nearby CCTV cameras. However, even after six days, no accused has been arrested, which shows serious inaction on the part of the police.

RCBA strongly condemns this attack and requests the senior police officials to take immediate and proper action

Accordingly, it has been unanimously resolved that a **STRIKE/ABSTINENCE FROM WORK** is called for tomorrow i.e 25th March 2026 to show solidarity and brotherhood among the members of the fraternity.

However, bail matters and stay matters shall remain exempted from the strike.

All members are requested to support Advocate Pawan Bhardwaj and his family in this difficult time and to cooperate.

Hon'ble Principal District & Sessions Judge of District North- West & District North are also requested to Co-operate and also request the Judicial Officers of both the Districts to Co-operate and not to pass any Adverse Order in any matter.
