ORDER:

The grounds of detention etc., of the detenu, Thiru. A.Shankar @ Savukku Shankar, male, aged 50 years, S/o. Thiru. Achimuthu, residing at No.1417, TVS Emerald Light House, 200 Feet Radial Road, Zamin Pallavaram, Chennai - 600 117, Permanent Address: No.12/6, TNHB Flats, Maduravoyal, Chennai - 600 095 were placed before the Advisory Board under section 10 of the Tamil Nadu Preventive Detention Act, 1982 (Tamil Nadu Act 14 of 1982). The Advisory Board perused the grounds of detention, report of the detaining authority sent to the Government, the connected records and also heard the oral representation of the detenu. The Advisory Board has expressed its unanimous opinion that there is no sufficient cause for the detention of Thiru. A.Shankar @ Savukku Shankar. Accordingly, the Government, in accordance with the provisions of subsection (2) of section 12 of Tamil Nadu Act 14 of 1982, hereby revoke the order of detention, dated 09/04/2026 made by the Commissioner of Police, Greater Chennai against the said Thiru. A.Shankar @ Savukku Shankar and directs that Thiru. A.Shankar @ Savukku Shankar, male, aged 50 years, S/o. Thiru. Achimuthu, residing at No.1417, TVS Emerald Light House, 200 Feet Radial Road, Zamin Pallavaram, Chennai - 600 117, Permanent Address: No.12/6, TNHB Flats, Maduravoyal, Chennai - 600 095 be released forthwith from detention as there is no sufficient cause unless he has been detained under any other law or is serving any sentence having been convicted by any Court.
