URGENT NOTICE

SUBJECT: RESOLUTION EXPRESSING ZERO TOLERANCE TOWARDS JUDICIAL MISCONDUCT AND DECISION TO BOYCOTT COURTS WHERE JUDICIAL OFFICERS MISBEHAVE WITH MEMBERS OF THE BAR.

All members of the legal fraternity are hereby informed that an urgent meeting of the Executive Committee of the Shahdara Bar Association was convened on 06.08.2026 in view of the complaints being regularly received from many lawyers against Sh. S.S. Rathi, Ld. Principal Judge, Family Courts, East District, Karkardooma Courts, Delhi, and Ms. Ritika Kansal, Ld. J.M.F.C, Mahila Court, East District, Karkardooma Courts, Delhi, reporting instances of discourteous, humiliating and disrespectful treatment meted out to advocates while discharging their professional duties.

Despite our previous requests, reminders and complaints filed against the above named judicial officers by Shahdara Bar Association with the District Judge, East District, KKD Court Delhi neither any action has been taken against the above named judicial Officers, nor they have improved their conduct.

Today i.e. on 06.08.2026 Sh. S.S. Rathi, Ld. Principal Judge, Family Courts, East District, Karkardooma Courts, Delhi addressed one of the senior member of our bar as a "Dallal", which is totally unacceptable & cannot be tolerated at all.

The relationship between the Bench and the Bar is founded upon mutual respect, dignity and cooperation. While advocates are duty-bound to maintain the highest standards of professional conduct and courtroom decorum, Judicial Officers are equally expected to uphold the dignity of the institution by treating members of the Bar with courtesy, patience and fairness.

The Association wishes to make it unequivocally clear that it shall not tolerate any instance where an advocate is subjected to humiliation, intimidation, unwarranted
