Sanction is hereby accorded to the establishment of the Resident Office of the High Court of Jammu & Kashmir and Ladakh at New Delhi. The Resident office shall, inter alia:

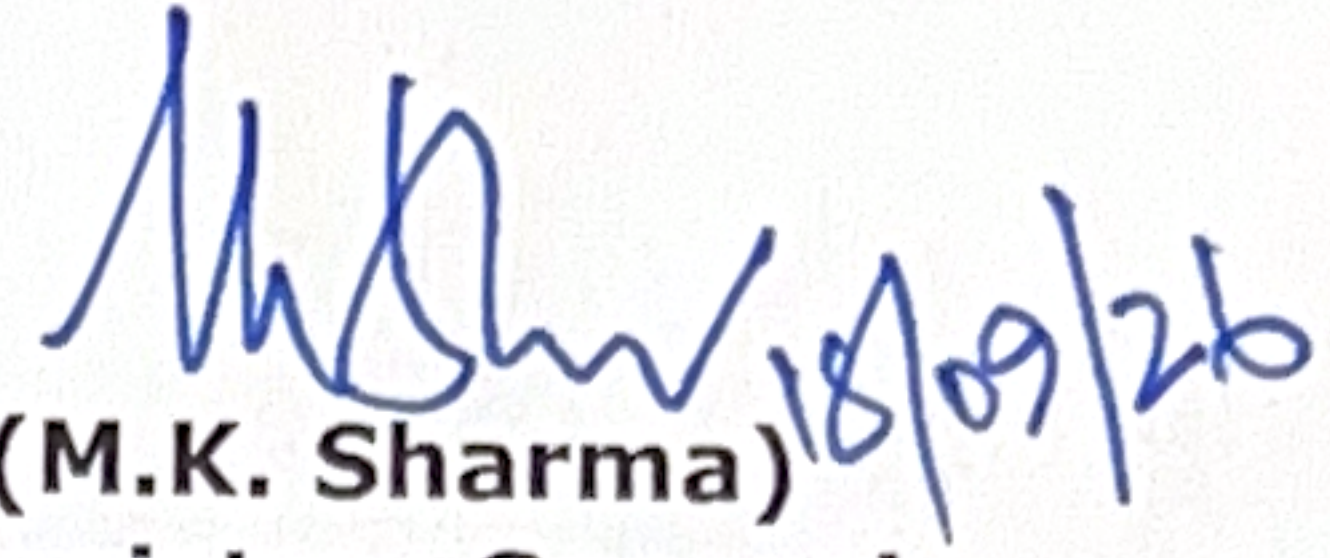
1. Coordinate with the Standing Counsel and other Counsels engaged on behalf of the High Court before the Hon'ble Supreme Court;
2. Monitor the progress of cases involving the High Court and ensure timely transmission of records, instructions, comments and responses;
3. Facilitate compliance with directions issued by the Hon'ble Supreme Court from time to time;
4. Facilitate handling of administrative and institutional matters requiring coordination at the national level;
5. Maintain regular liaison with the Registry of the Hon'ble Supreme Court, the Department of Justice, Government of India, constitutional authorities, judicial institutions, Ministries, Departments and other agencies situated at New Delhi;
6. Establish and maintain a secure channel for transmission and handling of confidential communications and sensitive matters requiring direct interaction between the High Court and the Hon'ble Supreme Court; and
7. Perform such other functions as may be assigned by the Hon'ble Chief Justice from time to time.

The Resident Office shall function under the supervision and control of the officer designated as **Registrar (Headquarters), New Delhi**, who shall be responsible for its administration, coordination and effective functioning.

The Registrar (Headquarters), New Delhi shall report to Hon'ble the Chief Justice through the Registrar General.

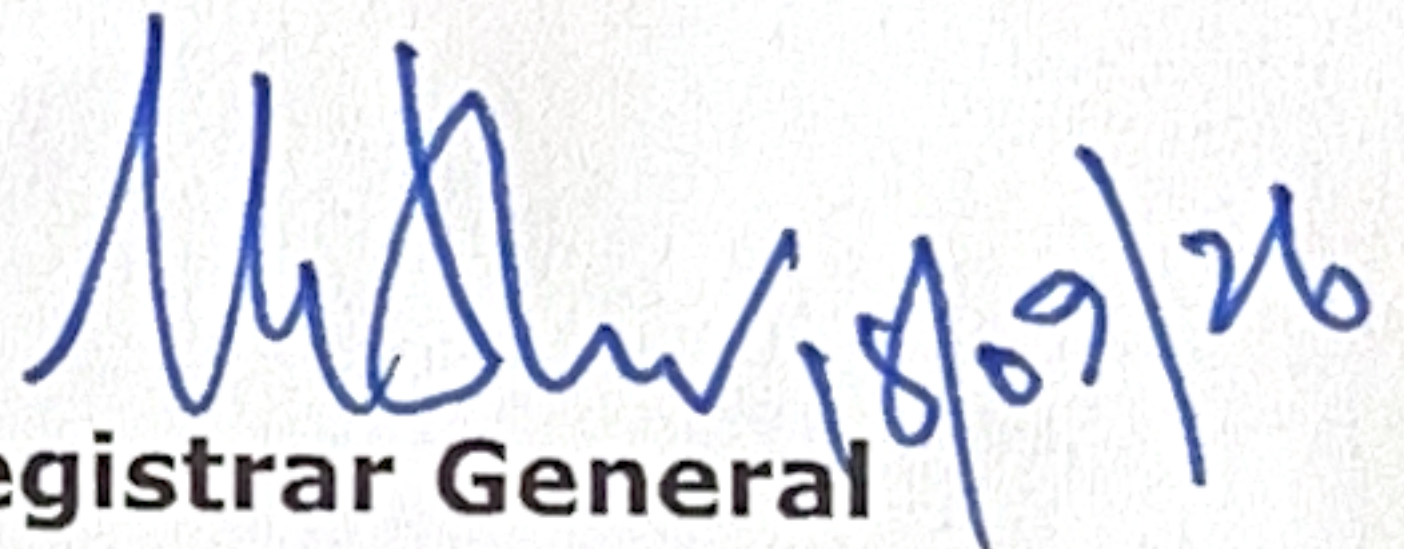
