



Company Overview

- GK Energy Limited, incorporated in 2008 and headquartered in Pune, Maharashtra, is a leading EPC company specializing in decentralized solar solutions, with expertise in the design, supply, installation, testing, and commissioning of solar photovoltaic (PV) water pumping systems.
- The company operates across three business verticals: (i) EPC for solar-powered pump systems under PM-KUSUM and state-level schemes, (ii) other EPC services including rural water supply projects under the Jal Jeevan Mission and rooftop solar installations, and (iii) trading of PV cells, solar modules, and allied products.
- As of 31 July 2025, GK Energy had successfully installed 97,098 solar pump systems across Maharashtra, Haryana, Rajasthan, Uttar Pradesh, Chhattisgarh, and Madhya Pradesh. It commands a 15% market share in Maharashtra under PM-KUSUM and has completed 62,559 systems nationwide under the scheme, representing a 7.4% share of total installations.
- As of 15 August 2025, the company maintained a strong Order Book of ₹1,028.96 crore, comprising ₹1,008.88 crore in Solar-Powered Pump Systems and ₹20.08 crore in rooftop solar projects, providing healthy revenue visibility and growth momentum.

Sector Outlook

- The Indian solar pump industry is expected to witness robust growth, driven by supportive government policies such as the PM-KUSUM scheme and various state-level solar initiatives. As of July 31, 2025, the five states of Maharashtra, Haryana, Rajasthan, Uttar Pradesh, and Madhya Pradesh accounted for 86% of approved solar pump systems, reflecting the strong concentration of opportunities in GK Energy's core markets
- India's broader renewable energy push, including the target of 500 GW of non-fossil fuel capacity by 2030, coupled with programs like the Jal Jeevan Mission, is expected to accelerate adoption of decentralized solar solutions for agriculture and rural water supply. This creates a favorable long-term growth environment for EPC providers like GK Energy

Company Outlook

- In FY 2024–25, GK Energy Ltd delivered robust financial performance, reporting revenue of ₹1,094.8cr, EBITDA of ₹199.7cr (18.2% margin), PAT of ₹133.2cr (12.1% margin), RoE of 63.7%, RoCE of 55.7%, and a debt-to-equity ratio of 0.74, underscoring strong growth, healthy profitability, and operational efficiency.
- GK Energy Ltd is raising approximately ₹464.26 crore through its IPO, comprising a fresh issue of ₹400 crore and an Offer for Sale of ₹64.26 crore, with proceeds primarily allocated to long-term working capital requirements of ₹322.46 crore and the balance for general corporate purposes, to support its operational expansion and growth plans.
- At the upper price band of ₹153, GK Energy Ltd is attractively valued, trading at a post-IPO P/E of 23.3x lower than its industry peers. The company has demonstrated strong financial performance, with significant revenue and PAT growth in FY 2024. Its robust order book and presence in the growing renewable energy sector further support its growth prospects. Considering these factors, the stock merits a “Subscribe” recommendation.

Key Risks

- The key risks for GK Energy Ltd include high customer and geographic concentration and seasonal business fluctuations can impact revenue, profitability, and cash flows.
