Sub:

1. Regarding refusing to file FIR under the provisions of Prevention of Atrocities Act of Scheduled Castes and Scheduled Tribe) on Murugan, Krishnan and their Family members, belonging to DMK political party, for carrying out the atrocities on me and my brother by attacking with stones and preventing the usage of my buildings and preventing construction of staircase to my building and grabbing my property with the help of Minister Durai Murugan.

2. File case on Minister Durai Murugan under Prevention of Atrocities on SCs/STs for promoting and inciting the violence and grabbing the land in collusion with DMK cadres accused Murugan and Krishnan.

Respected sir,

I am the resident of the above village with my land located at the above said serkadu cross road/Anna nagar address and I belong to Scheduled caste. I was constructing the stair case to my building located at my land in the said address.

Murugan and Krishnan along with his family members attacked me and my brother with stones and prevented us building the staircase to my building located on my land. He abused me and brother with the filthy and bad languages in the public place and prevented using the building and property and grabbed my land. This was carried out on two occasions i.e on the afternoon of 28.05.2021 and in the morning of 29.05.2021. In this regard two complaints were given. However CSR was given to only one complaint dated 28.05.2021 bearing CSR NO.260/2021 and refused to issue CSR to the complaint dated 29.05.2021.

Meanwhile all the documents and evidences were handed over to the Sub-Inspector of Police Mr.Muthuselvam and Inspector Mr.Anandan of Thiruvalem police station, katpdai taluk and even to the present Katpadi DSP Mr.Palani, but till date no action was taken by them on my complaints.

Meanwhile Mr.Narayanan, Sub-inspector of Police from thiruvalem Police station, prior to two days of this incident had threatened me and my brother to stop cutting the trees on my land , but on refusal he threatened to file case on us both.

Meanwhile, since there was no action on my complaints, appeals were sent to Superintendent of Police. There was the direction to DSP to take appropriate action on my complaint. A letter was issued on this regard on 26.06.2021. Thereafter other appeals were given to Chief secretary, DGP, Chief Minister and even then no actions were taken till date. Meanwhile a notice was issued by the Inspector Mr.Anandan for the investigation. I had participated in the investigation and submitted all the documents and evidences on 14.07.2021 and 15.07.2021. However, the Inspector refuses to File FIR and DSP is refusing to take any action on my complaints.

Meanwhile, to my surprise I was intimated yesterday evening (15.07.2021) by the police sub-inspector Mr.Muthuselvam that a complaint has been filed by Murugan and his family members on me and my brother. I was forced to withdraw the case on them and if I am not withdrawing, I was informed that FIR will be filed on me and my brother. The Sub-inspector of Police Mr.Nraranayan in collusion with the accused and DMK MLA and present Minister Durai Murugan are fabricating the false case on me and my brother with the influence of DMK party leaders and local MLA/ Minister Duria Murugan, Also the accused Murugan and his family members are relation of Minister Durai Murugan and belongs to DMK party and accused Krishnan's son Perumal is the Katpadi Taluk youth wing secretary of DMK party.

In this regard, so far no action had been taken on my complaints and Police officials and DMK Political leaders under the supervision of Durai Murugan are involved in this case and the police officials are on dereliction of their duties.

Already a similar issues of land grabbing and encroachment is still pending for more than 18 months ON the file of FIR No.103/2020 with the case pending before the National Commission for Scheduled Castes on file No.(TN/3/2020 APCR) against the accused Murugan and Krishnan and till date No Charge sheet had been filed. It is learnt that on the formation of DMK government, many of the crucial documents were destroyed, removed and missing in the said file to weaken the case and to help Murugan an Krishnan.

These two accused were awarded three years sentence On the file of CRLRC No. 1516/2013 by the Hon'ble High Court of Madras. Now these two accused are already on Supreme Court bail from 13.11.2019. The Supreme Court case file with Diary No.39205/2019 with SLP(Crl) No.010306/2019 is still pending. After

availing the bail, so far these accused had carried out many number of similar atrocities for around ten times when they are on bail. These types of atrocities are carried on my family for around 40 years. There is very much danger to the life and property of all my family members. These accused started doing with the help of Minister Durai Murugan and Durai Murugan is very much involved in supporting and promoting and inciting the caste atrocities on me and my family members continuously for around forty years and now on becoming the minister Durai murugan carries out freely, happily and with more power and inciting the violence on me and my family members with the help of police officials and accused and DMK party cadres

Prayers

I humbly pray to this Hon'ble Authority on considering the above facts and circumstances, kindly please to ;


1. Appoint one special independent officer in the rank of Superintendent of Police to conduct the enquiry on my complaints dated 28.05.2021 and 9.05.2021 and to file FIR on those complaints under Prevention of Atrocities on SC/STs Act.
2. Order to file case on the Minister Durai murugan for inciting and promoting violence with the help of accused Murugan, Krishnan and family members under Prevention of Atrocities on SC/STs Act.
3. Order to provide the police protection for me and to all my family members.
4. Order to take appropriate legal action under Prevention of Atrocities on SC/STs. on Police Sub-inspector Mr.Narayanan for fabricating the false

complaints on me and my brother in collusion with the DMK party leaders and the accused.

5. Order to take appropriate legal actions under Prevention of Atrocities on SCs/STs on Police officials DSP Mr. Palani and Inspector Anand, Sub-inspector Muthuselvam for dereliction of their duties.
6. Order to provide Pistol/Gun and police protection to protect me and my family members from these castist and politically connected members.
7. Order to initiate appropriate action to cancel the Bail of the accused to prevent further atrocities on me and my family members.
8. Any other appropriate orders in the interest of justice.
