Sub:- Detention of Mehraj Din Malik S/o Shamas Din R/o Tandla Tehsil Chilly Pingal, District Doda under Section 8 of J&K, Public Safety Act, 1978.

1. Whereas, through the dossier re-submitted by the Senior Superintendent of Police, Doda, vide No. Conf/PSA/2025/23634/C dated: 07.09.2025, report of Executive Magistrate (Tehsildar) Kahara, vide No. 301-307/Gen/TK dated:- 06.09.2025 and reliable information available with this office, it has been brought to notice that the subject namely Mehraj Din Malik, S/o Shamas Din, R/o Tandla, Tehsil Chilly Pingal, District Doda, is a history sheeter of PS Gandoh and has become a habitual offender overtime, involved in a number of criminal cases registered against him at various Police Stations across the Union Territory. The subject is currently serving as an MLA from Doda-52 constituency and is known to assert himself as a self-styled leader, frequently resorting to unlawful means to subdue the government procedures, rules and laws, while making irresponsible statements as if law of land does not apply to him being a lawmaker and while doing so, disturbs the public peace and tranquility to get his ill-designs implemented by force, threats and violence. His modus operandi includes using social media handles especially 'Facebook Live' to mount verbal and derogatory attack on anybody who tries to stand up against his illegal demands and while spreading false information to more than 2 lakh followers on his social media handles and innocent public on ground instigates the public, particularly the youth, to indulge in unlawful activities, create law and order problems, and disrupt public life, particularly within the sensitive areas of District Doda.

Despite multiple legal actions, including FIRs and other preventive measures taken against him from time to time, the subject has neither mended his ways nor shown any inclination to desist from such prejudicial activities. Instead, he openly defies each and every advice rendered to him as an Hon'ble lawmaker and public representative to act under law and guide public following him in right direction. Instead, the subject has been recorded to incite public to burn Govt offices and to act 'as Lashkars like Burhan Wani', to get all illegal demands met through force, threats and heckling / physical assault. The subject, who clearly believed in goondaism, having no respect for law of land, is habitual of hurting sentiments of public on multiple occasions and misguiding / provoking youth like terming followers of one particular religion as 'addicted to liquor' or motivating youth to consume Chitta (drugs) to increase Intelligence Quotient (*Akaal*), which has every propensity to benefit evil designs of organisations like militant groups and enemy states to create an environment of mistrust, infighting and pooling illegal gains from drug abuse to not just cause public order situation, but also wage war against society and state. It has been reliably reported that the subject's continuous involvement in such criminal, anti-social, prejudicial, and inflammatory / provocative activities pose a serious and persistent threat to the maintenance of public order in the District, especially at such a time when the District is reeling with large scale damage to both public infrastructure as well as loss of at least five human lives, 500 cattle, and over 700 private structures throughout the District. His deliberate actions are aimed at disturbing communal harmony, provoking unrest, and jeopardizing the peaceful atmosphere in the region, and forcing government mechanism to attend to his 'synthetically' created public order issues, instead of reaching out to public with relief material, medicines, life-saving drugs and resorting essential services required to lead productive and peaceful

community life. As per report of Executive Magistrate and police dossier, on a recent occasion demanding immediate action for the benefit of people especially the sick and infirm, the subject has been booked under law for theft and keeping under lock of essential medicines required to be disbursed to them after 10 days of the health centre being in dilapidated condition due to collapse during natural calamity and the area being disconnected from the rest of the world due to road closure and any amount of persuasion didn't motivate the subject from returning the same to medical staff for further disbursement to the poor people of the area.

2. The subject being a history-sheeter has a proven track record of involvement in multiple criminal and anti-social cases, as evident from multiple FIRs and Daily Dairy reports registered against him, which are summarized as under:

The criminal cases registered against the subject are enumerated as under:-

01. FIR No. 22/2014 U/S 353/323/504/RPC of P/S Gandoh.

The Brief facts of the case are that on 21-04-2014 at about 16:45 hours one Mst. Mastoor Begum W/O Layaket Ali Wani R/O Tandla Tehsil Chilly Pingal alongwith her Husband lodged a written report in this P/S dully endorsed by Hon'ble JMIC Gandoh U/S 156(3) Cr. PC which revealed that the complainant is Govt. employee in education Deptt. and presently posted at Govt. Middle School Tandla as Head Master. On 15th April 2014 at about 15:45 hours the complainant was performing election related duty at Govt. Middle School Tandla, which is notified polling Booth, suddenly Mehraj Din S/O Shamas Din Malik (Subject) and Shamas Din S/O Abdullah both R/O village Tandla Tehsil Chilly Pingal entered in School with criminal intention, used un-parliamentary language with complainant and also beaten the complainant. On this case FIR No. 22/2014 U/S 353/323/504/RPC got registered at P/S Gandoh and investigation commenced.

During the course of investigation of the case, I/O collected the evidences and established the commission of offences punishable U/S 353,323,504 RPC against the subject and other accused person. The investigation of the case was closed as challan vide challan No. 19/2014 which got produced in the Hon'ble Court of JMIC Gandoh against the subject and other accused person U/S 353/323/504/RPC for its judicial determination. The subject was bailed out by the Hon'ble court and the case has been disposed of as compounded.

02. Case FIR No. 54/2016 U/S 341/504 RPC of P/S Gandoh.

The Brief facts of the case are that on 03-06-2016 SHO P/S Gandoh alongwith nafri of P/S Gandoh vide DDR No. 07 dated 03-06-2016, after performing Law & order duty came back in t P/S Gandoh. During duty at about 12:00 hours a protest under the chairman ship of Farooq Ahmed S/O Maqbool Dar R/O village Seel A/P Doda City along-with 01. Farooq Ahmed Wani S/O Mohd Shaban Wani R/O Tilogra 02. Nazir Ahmed S/O GH Haider Batt R/O Amritpura Chinyas 03. Mehraj Din S/O Shamas Din Malik R/O Tandla (Subject) 04. Mohd Iqbal Batt S/O Mangtoo Batt R/O Pillie Tilogra Tehsil Chilly Pingal 05. Din Mohd S/O Abdul Satar Batt R/O

Batogra Tehsil Kahara 06. Gul Mohd S/O Mohd Din R/O Chanti Balla Tehsil Gandoh and others was held against Rural Development Deptt. During protest the above mentioned 07 persons stoped the vehicle Road Gandoh to Thatri at Bus Stand Gandoh with criminal intention and used un-parliamentary language. Due to blocked road they kept the public in difficulty. On this case FIR No. 54/2016 U/S 341/504/RPC got registered P/S Gandoh and investigation commenced.

During the course of investigation of the case, I/O collected the evidences and established the commission of offences punishable U/S 341/504/147 RPC against the subject and other accused persons. The investigation of the case was closed as challan vide challan No. 33/2016 which got produced in the Hon'ble Court of JMJC Gandoh against the subject and other accused persons U/S 341/504/147 RPC for its judicial determination. The case has been disposed of by the Hon'ble court on 31-03-2018 as withdrawn from prosecution as per the amnesty granted by the Govt. of Jammu & Kashmir.

03. Case FIR No. 59/2016 U/S 336/504/353/427/147 RPC of P/S Gandoh.

The brief facts of the Case are that on 13-06-2016 a complaint No. SDG/Clt/2016/2700-04 dated 13-06-2016 of SDPO office Gandoh along with complaint of BDO Block Gandoh was received in P/S Gandoh which revealed that on 13-06-2016 around 100 to 150 people being led by one Farooq Ahmed Dar S/O Maqbool Dar R/O Seel Doda unlawfully assembled outside the office of under signed and started shouting slogans and used abusive language against the officials of Rural Development. The said Farooq Ahmed Dar was also assisted in provoking the public by few miscreants whose names are Mohd Yasin Batt S/O Mohd Iqbal Batt R/O Malikpura Tilogra Mehraj Malik R/O Tilogra (Subject) and some other. At around 15:00 hours when undersigned along with Assistant Commissioner Development Doda along with other officers tried to pacify the public, the above-mentioned miscreants provoked the mob to enter the office premises of undersigned, consequently some 15/20 people from the mob entered the office and started ransacking and rampaging the office record and furniture. The mob started pelting the stones on the office of the undersigned, damaged the main gate, other furniture and some official record. The miscreants also attacked the officials of the office, who were on

official duty. On this case FIR No. 59/2016 U/S U/S 336/504/353 /427/147/RPC got registered P/S Gandoh and investigation commenced.

During the course of investigation of the case, I/O collected the evidences and established the commission of offences punishable U/S 452/427/353/336/504/147 RPC against the subject and other accused persons. The investigation of the case was closed as challan vide challan No. 34/2016 which got produced in the Hon'ble Court of JMJC Gandoh against the subject and other accused persons U/S 452/427/ 353/ 336/504/147 RPC for its judicial determination. The case has been disposed of by the Hon'ble court on 31-03-2018 as withdrawn from prosecution as per the amnesty granted by the Govt. of Jammu & Kashmir.

04. Case FIR No. 103/2021 U/S 353/427/504/IPC of P/S Gandoh

The brief facts of the case are that on 01-11-2021 a complaint of Tehsildar Chilly Pingal duly endorsed by Hon'ble Addl. District Magistrate Doda vide No. 1342-44/DM dated 30-10-2021 and No. SDG/Clt/21/2887 dated 01-11-2021 of SDPO Office Gandoh was received in P/S Gandoh through Dak, which revealed that on 27-10-2021 at about 10-30 am as per the statement of the employee's posted at N.T office Jakyas that person namely Mehraj Din Malik S/o Shamas Din Malik R/O Tandla (Subject) broke the lock attached to the already open door of court room of N.T and started abusing the employees. It is pertinent to mention that the Naib Tehsildar has been sent to the undersigned for the physical verification of pending category certificate (EWS). The N.T upon being informed by his staff immediately rushed to his office and upon reaching was intimidated, physically harassed and abused by Mehraj Din Malik and his associates in full public that had gathered there. The undersigned upon receiving the information and rushed to the spot and in order to avoid any Law-and-Order situation, directed whole staff of Nayabat Jakyas to attend the office of undersigned. The said person damaged the public property, physical assault on public servant, restraining the public servant from performing their duties. On this case FIR No. 103/2021 U/S 353/427/504/IPC got registered at P/S Gandoh and investigation started.

During the course of investigation of the case, I/O collected the evidences and established the commission of offences punishable U/S 353/504/427/IPC against the subject. The investigation of the case was closed as challan vide challan No. 85/2021 which got produced in the

Hon'ble Court of JMIC Gandoh against the subject U/S 353/504/427/IPC for its judicial determination. The case is subjudice before the Hon'ble Court. The subject is bailed out in the instant case.

05. Case FIR No. 103/2023 U/S 341/504/506 IPC of P/S Gandoh

The brief facts of the Case are that on 23-12-2023 one Ashiq Hussain S/o Mohd Rafiq Malik R/O Tilogra Tehsil Chilly Pingal lodged a written report in P/S Gandoh, which revealed that 21-12-2023 at about 1500/1600 hours complainant was on his way from Jakyas towards Malikpura in his personal vehicle bearing Regd. No. JK-06-5781 when reached at Magni Bhatyas suddenly Mehraj Din S/o Shamas Din R/O Tandla (Subject) and other un-known persons restrained his way with criminal intention, used un parliamentary language and also threatened him. On this case FIR No. 103/2023 U/S 341/504/506/IPC got registered at P/S Gandoh and investigation started.

During the course of investigation of the case, I/O collected the evidences and established the commission of offences punishable U/S 341/504/506/IPC against the subject. The investigation of the case was closed as challan vide challan No. 88/2023 which got produced in the Hon'ble Court of JMIC Gandoh against the subject U/S 341/504/506/IPC for its judicial determination. The case is subjudice before the Hon'ble Court. The subject is bailed out in the instant case.

06. Case FIR No. 105/2023 U/S 153-A/295-A/IPC of P/S Gandoh

The brief facts of the Case are that on 27-12-2023 one Baldev Singh S/o Tej Ram R/o Ghill Tehsil Gandoh Produced a memorandum of Hindu Jan Sabha Bhalessa mentioning that on 27-12-2023 a meeting of Hindu Jan Sabha was called under the president ship of Sh Baldev Singh at Gandoh. During meeting the viral video on social media of one Mehraj Din DDC Kahara (Subject) against RSS was discussed. Mehraj Din in viral video has stated against the uniform of RSS and Hindu community and has hurt the sentiments of Hindu community particularly. The whole Hindu community is in grief and angry. He has also stated in his viral video against the nation and tries to instigate the youth of majority community against Hindu community. He in his viral video tries to spread the hatred between two communities which can create law and order problem in Bhallessa any time etc. On this case FIR No. 105/2023 U/S 153-A/295-

A/IPC got registered at P/S Gandoh against the subject and investigation of the case commenced. The case has been closed as not admitted vide final report No. 04/2024 dated 27-07-2024.

07. Case FIR No. 55/2023 U/S 307/332/336/323/341/147/ 148/IPC, 3/4 PDPP Act of P/S Bahu Fort Jammu.

The brief facts of the case are that on 04-02-2023 a docket from PSI Mohd Saif Khan EXJ 196267 officer Police Post Bathindi was received at Police Station Bahu Fort Jammu which revealed that I/C Police Post Bathindi along with nafri of PP Bathindi, nafri of DPL Jammu, SHO P/S Bahu Fort, SDPO City East Jammu, SP City South and SSP Jammu and Addl. DC law & order along with other staff of revenue Dept. was performing duty at Malik Market Jammu in connection with anti-encroachment drive. During performing duty at about 17:15 hours suddenly a protest started shouting slogans coming from Narwal under the leadership of 01. Mohd Irshad S/o Mohd Ramzan R/o Kishtwar A/P Malik Market 02. Mohd Mushtaq S/o Mohd Shoket R/o Khagreyain Bihar A/P Malik Market 03. Maneer Ahmed S/o Not Known R/O Kishmir 04. Shahbaz Ahmed S/O Nasir Khan R/O Bagalyaz A/P Rama Channi Jammu. When they along with other person reached at near MG Hactor showroom, where anti-encroachment drive is progress, they attempt to murder, pelted stones upon Police party/revenue official and macheniery (JCB) which was used for anti-encroachment drive. They also blocked National High Way and way of public. They also shouting slogans against Govt. of UT J&K. On this case FIR No. 55/2023 U/S 307/332/336/323/341/147/ 148/IPC, 3/4 P D PP Act was registered at P/S Bahu Fort Jammu and investigation commenced.

During course of investigation and as per the statements of witnesses Mehraj Din Malik S/O Shamas Din Malik R/O Tandla (subject) has been found to be involved in the said case. The investigation of the case is underway. The subject is bailed out in the instant case.

08. Case FIR No. 46/2024 U/S 188 IPC of P/S Gandoh

The brief facts of the case are that on 03-05-2024, a letter received in P/S Gandoh through dak from the Office of Additional District Dev. Commissioner Doda (Nodel Officer MCC) vide endorsement No

ADDC/D/No-MCC/2024-25/397-400 Dated 02.05.2024 mentioning therein that, since the announcement of Lok Sabha Election-2024, Model Code of Conduct has come into force w.e.f 16.03.2024 and shall continue till 06.06.2024. But Mehraj Din Malik (Subject), Independent Candidate time and again is violating Model Code of Conduct by organizing rallies, using loudspeaker without permission. During the period of Model Code of Conduct gathering of more than 04 persons without permission of competent authority and use of loudspeaker is prohibited. Whereas, on April 29, 30th and May 1st, 2024 Mr. Mehraj Din Malik, Independent Candidate organized rally using loudspeaker at Block Headquarter Jakayas (52-Doda-West constituency), instigating the public to breach peace and tranquility. On this case FIR No 46/2024 U/S 188/IPC got registered at P/S Gandoh against the subject and investigation started. The subject has been bailed out in the instant case and the challan of the case has been presented vide challan No. 05/2025 against the subject before the Hon'ble Court of law.

09. Case FIR No. 47/2024 U/S 188 IPC of P/S Gandoh

The brief facts of the case are that on 04-05-2024, a letter received P/S Gandoh through dak from the Office of Additional District Dev. Commissioner Doda (Nodel Officer MCC) vide endorsement No ADDC/D/No-MCC/2024-25/401-404 Dated 02.05.2024 mentioning therein that, since the announcement of Lok Sabha Election-2024, Model Code of Conduct has come into force w.e.f 16.03.2024, but Mehraj Din Malik(subject) Independent Candidate for Lok Sabha Election 2024 organized a rally at Gowari Changa on 31.03.2024, used loudspeakers without permission. On 03-04-2024, Mehraj Din Malik was served show cause notice but did not respond to the notice. Again on 10-04-2024 he was asked to clarify his position through final notice No. ADDC/D/No-MCC/2023-24/222-236 but till date he has not submitted his reply. On this case FIR No. 47/2024 U/S 188 IPC got registered at P/S Gandoh against the subject and investigation started. The subject has been bailed out in the instant case and the challan of the case has been presented vide challan No. 07/2025 against the subject before the Hon'ble Court of law.

10. Case FIR No. 48/2024 U/S 353/452/147/504/506 IPC of P/S Gandoh

The brief facts of the case are that on 04-05-2024 a letter of BDO Jakyas vide No. BDO/J/24-25/107-115 dated 04-05-2024 along with letter No. BDO/J/2024-25/97-103 dated 01-05-2024 was received in Police Station Gandoh through Dak mentioning that On 29th of April, 2024, while complainant was attending a meeting in the Office of Assistant Commissioner Development Doda, complainant received a call from Mr. Mehraj Malik (subject), District Development Councilor Kahara, inquiring about complainant absence from the block headquarter. Complainant respectfully informed him that he is engaged in the meeting and assured him of his presence at the block headquarter as soon as possible. Subsequently, it was brought to complainant attention by staff stationed in the office that Mr. Malik, accompanied by his associates and approximately 20-30 individuals, entered the office premises without authorization and were behaved in an unruly manner towards the staff. Upon receipt of this information, the complainant attempted to address the situation by contacting Mr. Malik via telephone, however, the complainant was met with a confrontational and threatening response instead. Upon the conclusion of the meeting at 2:00 PM in the office of Assistant Commissioner Development, Doda, complainant expedited return to the block headquarter Jakyas, arriving at approximately 5:00 PM, and that time Mr. Malik had left the office premises. On April 30, 2024, when complainant reached office and found that Mr. Malik, along with his associates and a large group of individuals, (approximately 50-60) once visited the office premises and while the undersigned was sitting outside with Mr. Malik, he and his associates unexpectedly started shouting slogans against BDO, RDD Department and the whole District Administration. Despite the hostile environment created by Mr. Malik and his goons, the complainant endeavored to engage in a dialogue with Mr. Malik and requested the cessation of filming and live streaming the event to de-escalate the prevailing tense atmosphere as it was totally unwarranted. On the day in question, discussion initially started regarding the grievances related to the Gram Rozgar Sahayak (GRS) but escalated unexpectedly since Mr. Malik and his associates exhibited a level of aggression that was both unwarranted and deeply unsettling. Despite the hostile atmosphere, complainant team and he endeavored to maintain a

demeanor of professionalism and calm. They sought to address the concerns raised, while ensuring that due process was followed. Unfortunately, the situation deteriorated when Mr. Malik forcibly snatched complainant personal mobile phone and issued illegal ultimatum for the immediate termination of the GRS concerned. Complainant immediately constituted an inquiry committee vide order No. BDO/J/2024-25/72-79 Dated:- 30-04-2024 and order no. BDO/J/2024-25/80-87 dated 30-04-2024 to look into the matter and also attached one GRS in BDO office and relieved another to the office of ACD Doda, However, in the meantime, a group of women and few men entered in the office of complainant and came close to complainant table and started yelling and thumping to the complainant table thus creating a threatening atmosphere the complainant had showed attachment orders, concerned women and men seemed satisfied and told the complainant that they will leave now. On hearing this, Mr. Mehraj Malik and his associates who have a known history of intimidating public officials, forcibly entered the office of complainant and coerced the complainant to step outside, where a large mob of approximately 50-60 people had gathered. Mr. Malik incited the crowd towards the District administration and due to which few persons from the crowd became highly aggressive and began to heckle the complainant, creating a hostile environment. Mr. Mehraj Malik confronted the complainant publicly with abusive language, manhandled the complainant and threatened him besides demanding immediate termination of GRS's, which the complainant resisted, explaining that due process was being followed. The complainant informed him of the inquiry committee that had been set up to investigate the matter and that any action would be taken based on their report within three days under rules. However, this did not pacify the situation. Mr. Malik grabbed the arm of complainant and threatened him to comply with his directions immediately else he will kill the complainant, and his staff. Despite the pressure, the complainant stood firm on following the rules and procedures. In response, he ordered his associates to prevent the complainant from leaving the office until the GRS was terminated, therefore creating a hostage like situation. Upon incitement by Mr. Malik, the complainant was taken hostage in his own office by his associates and by this he prevented the complainant from performing his official duties under rules. Mr. Malik along with mob created a scene of threatening atmosphere by yelling with abusive language. Keeping in view the safety of the complainant life and lives of

office staff, the complainant called ACD Doda and SDM Gandoh and requested them to rescue the complainant without any delay. In the meantime, Tehsildar Chilly Pingal along with some police personnel arrived at the spot but still the situation was worsening as Mr. Mehraj Malik, along with his associates planned and executed a disruptive and violent act that not only endangered the complainant safety but also disrespected the sanctity of governmental office and its functioning. As Tehsildar Chilly Pingal and the complainant were trying to control the situation, Mr. Malik forcefully pushed the complainant towards my office room and told the complainant to stay there and work overnight to get the GRS's concerned terminated on spot. Taking cognizance of the situation, Tehsildar Chilly Pingal called SDM Gandoh who alongwith SDPO Gandoh and SHO Gandoh arrived at Block Headquarter Jakyas and were able to rescue the complainant out from the complainant's office where the complainant was held as a hostage till around 7:00 PM. In light of the above narrated incident, the following points outline the grounds for taking strict action amounting to Lodging of an FIR also against Mehraj Malik and his associates 1. Obstructing a public servant from performing his duties by use of criminal force. 2. Heckling, manhandling, and misbehaving with a government official on duty. 3. Taking a government officer hostage while on duty. 4. Inciting mob to create violence in Govt. premises. 5. Creating a political stunt in the office premises. 6. Making Government Office un-functional for 3 days by illegally occupying the whole office. 7. Filming and live streaming office events forcibly without permission. 8. Threatening to kill me and my office staff. 9. Abusing and manhandling of Government Officer on duty. 10. Intimidating Govt. Officer to act as per his whims and fancies. 11. Snatching of order copies and official files. On this case FIR No. 48/2024 U/S 353/452/147/504/506 IPC got registered at PS Gandoh against the subject and investigation of the case commenced. The case is still under investigation. The subject is bailed out in the instant case.

11. FIR No. 212/2024 U/S 223/BNS of P/S Doda.

Brief facts of the case are that on 27-08-2024 a complaint was received from the officer of Deputy Commissioner Doda regarding violation of Model Code of Conduct mentioning therein that the AAP candidate namely Mehraj Malik (subject) has violated the Model Code of conduct and organized a rally at Sports Stadium Doda despite repeated requests by

FST 01 and FST 03 AC-52 Doda in presence of Nodal officer Doda which is a violation of MCC and section 163 BNSS 2023 has been imposed by the District Magistrate Doda. On the contents of the complaint a Case FIR No. 212/2024 U/S 223/BNS got registered at P/S Doda. The investigation of the case is underway.

12. Case FIR No. 92/2024 U/S 223 BNS of P/S Gandoh

Brief facts of the case are that on 07-09-2024 a letter was received in Police Station Gandoh from the office of the Flying Squad FST No. 06 AC-52 Doda Station Kahara District Doda to the effect that Sh. Mehraj Ud Din Malik S/O Shamas Ud Din Malik R/O Jakyas (subject) who is contesting as AAP candidate from AC-52 Doda in general election to the legislative Assembly of J&K (UT) has violated the norms of Model Code of Conduct by organizing an unauthorized public rally on 27-08-2024 in main market Kahara without seeking permission from the prescribed authorities amounting to disobedience of order No. 1650-51/DM/Doda dated 17-08-2024 by virtue of which section 163 of Bhartiya Nagrik Suraksha Sanhita is in force in the District. On the basis of the contents of the letter the case FIR No. 92/2024 U/S 223 BNS got registered in P/S Gandoh. The challan of the case has been presented vide challan No. 50/2025 against the subject before the Hon'ble Court of law.

13. FIR No. 229/2024 U/S 132/351(2)/352/223/BNS of P/S Doda.

Brief facts of the case are that on 08-09-2024 a complaint was received from the Magistrate Flying Squad Team 09, AC-52 mentioning therein that on 08-09-2024, during routine checking by Flying Squad Team AC-52 Doda at Dali Morh one vehicle bearing registration No. JK 06-6090 (Tempo) has been stopped for checking. While checking of the vehicle was going on suddenly Mr. Mehraj Malik (subject) candidate of AAP along with his supporters appeared on the spot and misbehaved with the election duty staff and facilitated above vehicle to slip away from the spot. On the contents of the complaint case FIR No. 229/2024 U/S 132/351(2)/352/223/BNS got registered at P/S Doda. The investigation of the case is underway.

14. Case FIR No. 94/2024 U/S 126 (2), 115 (2), 351 (2), 352, 307, 324(4) BNS of P/S Gandoh.

Brief facts of the case are that on 13-09-2024 one person namely Kanchen Kant S/O Mela Ram R/O Sanwara Tehsil Gandoh came to Police Station Gandoh in injured condition and filed a written complaint mentioning therein that today in the evening at about 07:00 PM, he along with driver namely Vinay Kumar was coming back from Gali Bhatoli area towards Sanwara in a vehicle load carrier bearing registration No. JK 06B-5997. When they were about to reach Sanwara, a rally of contesting candidate Mehraj Din Malik (subject) came and Mehraj Malik and his supporters stopped his vehicle, used abusive language, beaten him, broken the window pane of his vehicle and snatched Rs. 150000/- which he had collected after selling the Keryana items to shopkeepers and threatened him of dire consequences. The investigation of the case is under way.

15. Case FIR No. 96/2024 U/S 223 BNS of P/S Gandoh.

Brief facts of the case are that on 14-09-2024 an application from the Tehsildar FST-6, 52 Doda, Kahara was received in Police Station Gandoh mentioning therein that permission vide No. 9735-45/DM/Doda dated 11-09-2024 was granted in favour of Mehraj Ud Din (subject) contesting candidate of AAP from 52-Doda at Kahara market on 13-09-2024 from 02:00 to 03:00 PM, whereas the said candidate conducted the public meeting beyond the given time till 04:50 PM thereby disrupting the movement of public and traffic. The said candidate also organized a public rally from Malanoo Bridge to Kahara Market without permission from competent authority thereby causing law and order problem and the said act of the candidate is a violation of Model Code of Conduct. On the contents of the application the case FIR No. 96/2024 U/S 223 BNS got registered at P/S Gandoh. The challan of the case has been presented vide challan No. 51/2025 against the subject before the Hon'ble Court of law.

16. Case FIR No. 99/2024 U/S 125 BNS of P/S Gandoh.

Brief facts of the case are that on 25-09-2024 a complaint along with letter of Worthy Nodal officer MCC ADC Doda was received in Police Station Gandoh mentioning therein that a 29 minutes Video has been

uploaded a day ago on the official page of Mr. Mehraj Malik (subject), AAP candidate from AC-52 wherein he has personally attacked Sh. Khalid Najeeb Suharwardy , JKNC Candidate from AC-52 leveling accusations against him. As per MCC guidelines no candidate / party / person can make attacks of personal nature against any candidate. On the contents of the complaint the Case FIR No. 99/2024 U/S 125 BNS got registered at P/S Gandoh. The investigation of the case is under way.

17. Case FIR No- 130/2025 U/S 356(2), 79, 351(2) BNS of P/S Doda.

Brief facts of the case are that complainant namely Dr. Madhu Chib, Associate Professor and Head Gynae and Obstetrics GMC Doda submitted a written application in Police Station Doda. The contents of application are as under:- To SHO Police Station, Doda Subject: Complaint against MLA Mr. Mehraj Malik (subject) for criminal intimidation, gendered abuse, and threat to Hospital security. Respected Sir, I, Dr. Madhu Chib, currently serving as Associate Professor and Head Gynae and Obs at GMC Doda, am compelled to write this letter to bring to your immediate attention a matter of utmost seriousness and concern involving the elected representative, MLA Mr. Mehraj Malik. In a series of deeply disturbing instances, Mr. Malik has used social media platforms to publicly issue threats and level abusive, gendered, and derogatory remarks against me. Phrases such as "gasheetonga" (I will drag you) and "nangakardunga" (I will strip you naked) have been used openly and maliciously. These are not mere words they are direct threats to my dignity, safety, and professional integrity as a female doctor serving in a Government hospital. These words clearly outrage the modesty of a female public servant that too on social media. Also please take cognizance that he has repeatedly used words like chor, dalae, haramkhor and qatil in his social media live videos. What is even more painful is his taunt: "This hospital doesn't belong to your father"-a statement that not only reflects arrogance but also extreme insensitivity, considering the fact that my father passed away over 12 years ago. Such remarks show utter disregard for human decency and violate the basic decorum expected from a public representative. Furthermore, he has labeled me as doing "dalali"-a term with disgraceful and sexually suggestive undertones when used in such a context, implying immoral conduct or brokerage for personal benefit. This not only tarnishes my professional reputation but also places me in grave social and psychological distress. In addition to these verbal threats, Mr. Malik's

conduct during hospital visits is erratic, threatening, and completely unbecoming of an elected representative. He has un-authorizedly entered the labour room-a sensitive and restricted area-accompanied by his associates and with live social media feeds running. This is a gross violation of patient privacy, especially for female patients in vulnerable conditions. His repeated actions are deeply distressing for both the staff and the patients and pose a direct threat to our hospital's security and ethical environment. Legal Basis for Complaint. The following provisions of the Bharatiya Nyaya Sanhita (BNS), 2023 are applicable: Section 74 (Criminal Intimidation): His threats to "drag" and "strip" me qualify as criminal intimidation with the intent to cause alarm or harm. Section 76 (Intentional Insult with Intent to Provoke Breach of Peace): The public use of derogatory and gendered language intended to provoke. Section 77 (Outraging the Modesty of a Woman): Remarks such as "nangakardunga amount to verbal sexual harassment and modesty outraging. Section 124 (House-trespass): Unauthorized entry into the labour room qualifies as criminal trespass into a protected space. Section 354 (Assault or Criminal Force to Woman with intent to Outrage Her Modesty): Though physical force has not occurred, his threatening language and presence in sensitive areas with a mob and cameras may be interpreted under this section as an attempt to create a hostile environment. My Earnest Prayers: 1. Immediate registration of an FIR against Mr. Mehraj Malik under the above-mentioned sections of the BNS. 2. Strict assurance from your office regarding my personal safety and that of my colleagues and patients. 3. Institutional restrictions on unauthorized entries into sensitive hospital zones like the labour room. 4. A formal inquiry into the misuse of power and violation of medical ethics and patient privacy during Mr. Malik's visits. As a law-abiding citizen and a public servant, I have full faith in the rule of law and the administrative machinery. However, I fear for my safety and dignity if swift and concrete action is not taken against this kind of political bullying. I request your urgent intervention in the matter and expect that the concerned authorities will uphold the sanctity of the medical profession and the rights of female professionals working under the shadow of intimidation, Thanking you. The SHO Gandoh, District Doda. Subject: Complaint regarding illegal trespass and theft of hospital equipment and other belongings and obstructing public servant in discharging duty while shifting of AAM Center, Kencha, Block Thathri-request for registration of FIR U/S 221, 303 BNS Sir, With reference to the subject cited above, I am writing regarding the theft done by individuals namely Mohd. Shafi S/O Mubarak Malik, Ghulam Ali S/O Abdul Sattar, Shoib Malik S/O Ghulam Ali, Jaffar Hussain S/o Mubarak Malik all residents of Village Kencha and another Sh. Sufian Malik S/O Mushtaq Malik R/O Malanoo, Tehsil Kahara, Mehraj Malik S/o Shamis Din R/o Tendla, Tehsil Chilli Pingal (subject) of hospital equipment and other belongings and also obstruction the Government servants namely Rajat Parihar (MLHP AAM Kencha) and ANM namely Ghazala Begum of AAM Kencha in shifting of the AAM Center, Kencha, Block Thathri. The AAM Center was earlier functioning in a rented building at Kencha, but since that structure was in dilapidated condition and one of its rooms had cracks in the walls was not suitable for delivering proper health services. The centre was functioning only in one room. A committee constituted by the then Block Medical Officer (BMO) Thathri after following due process recommended the house of Mr. Abdul Rashid S/o Abdul Aziz, R/o Village Kencha, as the most suitable for shifting of the centre. There was a conflict of interest between two parties Mr. Abdul Rashid S/o Abdul Aziz and Mr. Ghulam Ali S/O Abdul Sattar for the shifting of this centre. Due to this conflict and threats by one of the accused namely Mehraj Malik who also happens to be the MLA of Doda-52 constituency in Doda, the centre was allowed to continue the old designated building. But on account of recent heavy rainfall of August 26, 2025, one of the walls of the room in which the center was functioning also collapsed and it became impossible to continue

the health center in the same building as it posed risk to both the staff and the patients. Accordingly, it was decided to temporarily shift the staff to PHC Malanoo till the alternate arrangement is made. This issue was raised with the Chief Medical Officer Doda and it was advised to shift the center to already finalized new building belonging to Mr Abdul Rashid S/o Abdul Aziz in same village. After public uproar on non-functioning of AAM Kencha centre, on 4th September 2025, the staff of AAM Kencha was directed by the undersigned to shift the instruments, equipment, medicines and furniture to the house of Mr. Abdul Rashid S/o Abdul Aziz R/O Kencha as approved by the committee constituted by then BMO Thathri. On 5th September 2025, while the above-named staff was shifting the equipment and other belongings to the newly designated building, a group of people namely Mohd. Shafi S/O Mubarak Malik, Ghulam Ali S/O Abdul Sattar, Shoib Malik S/O Ghulam Ali, Jaffar Hussain S/o Mubarak Malik all residents of Village Kencha and Sufian Malik S/O Mushtaq Malik R/O Malanoo, Tehsil Kahara, Mehraj Malik S/o Shamis Din R/o Tendla, Tehsil Chilli Pingal, forcibly and illegally trespassed the premises and committed theft using force and threats and took away medical equipment and items including one table, 8 chairs, 3 stools, 3 dustbins and 3 Almirah along with all the official record of the centre of the health center, stretchers, glucometers, 2 beds with 1 mattress and many more material as per list attached unlawfully & kept under illegal possession in the building of the other accused namely Mr. Ghulam Ali S/O Abdul Sattar, R/O Village Kencha, Tehsil Kahara under lock. In this act, the accused namely Mehraj Malik who happens to be the MLA of the area threatened and obstructed the government officials in shifting the centre and all items to the new building decided by committee and instead committed theft in collaboration with the other above-named individuals and locked the equipment and other belongings in the house of Mr. Ghulam Ali S/o Abdul Sattar, R/o Village Kencha, Tehsil Kahara. The issue was reported by the staff of AAM Kencha to the undersigned and to resolve the issue, I visited the said location where to my surprise I found Hon'ble MLA Sh. Mehraj Malik already present there along with huge number of like minded people hell bent to prevent government officials from retrieving the government property. Hon'ble MLA directed me not to try and shift the center in the house of Mr. Abdul Rashid S/o Abdul Aziz and instead shift it in the house of Mr. Ghulam Ali S/O Abdul Sattar. The undersigned brought the issue into the kind notice of Chief Medical Officer Doda and

local administration to avoid any law-and-order problem. Subsequently, a team comprising the Chief Medical Officer Doda, SDPO Gandoh, Tehsildar Kahara, SHO Gandoh and the In-charge Police Post Kahara visited the location and they also attempted to retrieve the government property and resolve the issue amicably. Despite repeated efforts and explanations, the persons mentioned above refused to return the hospital belongings. This unlawful act has not only disrupted the functioning of a health facility meant for public welfare but also poses a risk of damage or misuse of valuable government property. In view of the above facts, it is requested to kindly: 1. Register an FIR against the involved persons for theft and unlawful possession of the hospital equipment, illegal trespassing and obstructing government servants in discharging lawful duty of shifting of the health center. 2. Take immediate necessary action to recover the medical equipment and restore it to its rightful place. 3. Initiate legal proceedings to ensure that such interference in public service delivery is not repeated. I request your urgent intervention in the matter and action as per law. On the contents of the complaint, the case FIR No- 90/2025 U/S 221,329 (3), 351(2) 305 (e), 191 (2) BNS got registered in P/S Gandoh. The investigation of the case is underway.

Besides, there are following adverse reports regarding his involvement in protests and provoking the people against the Government and Administration thereby creating law & order problem by repeatedly indulging in activities prejudicial to the maintenance of public order which have been entered in the daily diary of Police Stations/Police Posts of District Doda:-

i). DDR No. 19 dated 14-07-2021 of PP Kahara.

On 14-07-2021 a report vide DDR No. 19 dated 14-07-2021 was entered in the daily diary of PP Kahara to the effect that the Mehraj Din Malik DDC councilor (subject) gathered drivers and other persons at Kahara market Road and provoked the people against Administration, and disobeyed the COVID-19 rules and also disobeyed the traffic rules.

ii). DDR No. 32 dated 28-06-2021 of PP Kahara.

On 28-06-2021 a report vide DDR No. 32 dated 28-06-2021 was entered in the daily diary of PP Kahara to the effect that EX-MLA Sh. Ghulam Mohd Saroori along with EX-Sarpanch Farooq Ahmed Panchayat

Dherouth went at Kakota in the house of Abdul Rashid Khanday, on returning time 07/08 persons kept the big boulders on main Road and blocked the public road. The Mehraj Din Malik DDC councilor (subject) laid a protest and provoked the people against other Political Parties and created law & order problem.

On 04-08-2021 a report vide DDR No. 14 dated 04-08-2021 was entered in the daily diary of P/S Gandoh to the effect that one Javid Iqbal S/O Shamas Din Malik R/O Tandla lodged a complaint against Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal DDC member Block Kahara (subject), a preventive action under section 107/117 Cr. PC will be produced in the Court of EMIC. Further, the preventive action has been taken against the subject.

iv). DDR No. 16 dated 09-05-2022 of P/S Gandoh.

On 09-05-2022 a report vide DDR No. 16 dated 09-05-2022 was entered in the daily diary of P/S Gandoh to the effect that Road work of Bhatoli to ManooKutta was stopped since few days. On this Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal DDC member Block Kahara (subject), laid a protest at Malikpura against Govt. and Administration, due to which traffic on the road stopped and public also suffered.

v). DDR No. 13 dated 25-12-2022 of P/S Gandoh.

On 25-12-2022 a report vide DDR No. 13 dated 25-12-2022 was entered in the daily diary of P/S Gandoh to the effect that History Sheeter Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal DDC member Block Kahara (subject), was previously involved in Case (01) FIR NO.22/2014 U/S 353/323/504/RPC (02) FIR No. 54/2016 U/S 341/504/RPC (03) FIR NO. 59/2016 U/S 336/ 504/353/427/147/RPC (04) FIR NO. 103/2021 U/S 353/427/ 504/IPC and is even provoking the people against Govt. and Administration.

vi). DDR No. 12 dated 27-12-2022 of P/S Gandoh.

On 27-12-2022 a report vide DDR No. 12 dated 27-12-2022 was entered in the daily diary of P/S Gandoh to the effect that Deputy Commissioner Doda reached the venue with whole District officers and sectoral officers in respect of the programme "prashasangaon ki aur" to be held at

Gandoh head quarter on 23-12-2022 from 11 am onward. On the fixed date i.e. 23-12-2022 Deputy Commissioner Doda along with all District sectoral officers reached the venue and the programme started in a very smooth manner. The main aim of the programme was to reach out to the poorest of the poor. Worthy Deputy Commissioner in his speech has made it clear that this programme is meant for those who never got the opportunities to reach to the office of the District officers. After preliminary speeches, worthy Deputy Commissioner Doda started listening to the grievances of public in open one by one which was the main aim of the programme. while Deputy Commissioner Doda was listening and resolving the grievances of the poor masses and was also getting answers of the grievances of the aggrieved persons for concerned District officers. Some un identified planted persons started chanting "hello , hello, hello" from crowd three times just to disturb the smooth functioning of the porgramme and suddenly to utter surprise Block Development Chairman Changa, Sh. Mohd Abass rather stood up and started chanting slogans against the government and administration, reacting to this , some persons from the crowd also stood up and were backed by some miscreants with similar slogans and all these created disturbance and chaos at the venue and also disturbed the public order on spot. The way situation was worsened by miscreants at venue, this prima facie looked like a deliberate attempt on their part to disturb the law and order and communal harmony in the area. Due to the activities of the miscreants on the spot the situation got worst to worsened and the security forces were directed to control the situation. In the mean time, the Deputy Commissioner Doda along with all District officers stood up and left the venue. The Deputy Commissioner Doda also directed the security personals to control the deliberately created disturbance at the venue. These miscreants continued their activities and chanted anti-government and anti-administration slogans and used very vulgar language against the Government's Vision and Policies and also against all the officers who came there. It took almost two hours for security personals under supervision of SDPO Gandoh and SHO Gandoh to control the situation created by these miscreants at the venue. Prima facie, this all looked like a cooked-up movement of some miscreants there, some of them are already under FIRs and some have the same past history. It is pertinent to mention here that prior to this programme , Worthy Deputy Commissioner Doda few days ago has passed a strict

order to seize all the immovable and movable property of HM Commander , Abdul Rashid S/O Asrullah R/O Khanpura of Sub Division Thathri , who is still active in Pakistan and this order was implemented in letter and spirit by the administration there . All this deliberately created disturbance at the venue chaired by Deputy Commissioner Doda might have connections with that order too and in this regard an investigation is required at your end for clarification. As the miscreants were raising slogans against Government and administration at the venue chaired by Worthy Deputy Commissioner Doda. One of the miscreants namely Mehraj Din Malik DDC Kahara (subject) used abusive language against the Tehsildar Bhalessa and threatened him of life consequences The miscreants involved in creating law and order problem and thereby threatening the communal harmony at the venue are mentioned as below: 1. Mohd Abbass Rather (BDC Changa) 2. Mehraj Din Malik (DDC Kahara) 3. Ishtiyahq Ahmed S / o Mohd Shaban R / o Tendla, TilograJayas 4. Wasiyak Ahmed Tak S / OAnaytullahTak R /O Bhatyas. 5. Shahad Ahmed Zargar S /O Shoket Ali Zargar R /O Gundow. On this a report U/S 186/506/IPC was entered in this P/S and preventive section will be produced in the Court of EMIC. Further preventive action has been taken against the subject.

vii). DDR No. 06 dated 20-06-2023 of P/S Gandoh.

On 20-06-2023 a report vide DDR No. 06 dated 20-06-2023 was entered in the daily diary of P/S Gandoh to the effect that History Sheeter Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal DDC councilor Block Kahara (subject), often provoking the simple people against Police and Administration. Today he provoked one Hushyar Singh S/O Ram Lal R/O Sinoos Dalori and made him to viral a video from his phone.

viii). DDR No. 10 dated 24-12-2022 of PP Kahara.

On 24-12-2022 a report vide DDR No. 10 dated 24-12-2022 was entered in the daily diary at PP Kahara to the effect that on 23-12-2022 Deputy Commissioner Doda was organized a Block Diwas at Gandoh, while Deputy Commissioner Doda was listening and resolving the grievances of the poor masses and was also getting answers of the grievances, meanwhile DDC member Mehraj Malik Block Kahara (subject)

provoked the people and started hue and cry and viral some videos against Administration.

ix). DDR No. 20 dated 20-04-2024 of PS Gandoh.

On 20-04-2024 a report vide DDR No. 20 dated 20-04-2024 was entered in the daily diary at PS Gandoh to the effect that a letter from Addl. District Development Commissioner Doda Nodel officer MCC received at PS Gandoh regarding violation of model code of conduct by Mr. Mehraj Din Malik (subject) independent candidate for Lok Sabha Election 2024 organized meeting rally at Gowari on 31.03 2024 without permission in violation of model code of conduct. Whereas, vide No. ADDC/D/No-MCC 2023-24/37-49 dated 03.04.2024 he was served show cause notice through Station House Officer Gandoh but he did not respond to the notice, again on 10.04.2024 he was asked to clarify his position through final notice No: ADDC/ D/ NO-MCC 2023-24/222-236 through Station House Officer Gandoh, but till date he has not submitted his reply. In view of above the authority has approved lodging an FIR against Mehraj Din Malik.

x). DDR No. 24 dated 30-04-2024 of P/S Gandoh.

On 30-04-2024 a report vide DDR No. 24 dated 30-04-2024 was entered in the daily diary of P/5 Gandoh to the effect that History Sheeter Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal (subject) independent contesting candidate for Lok Sabha Election 2024, and provoking the people of Block Jakyas tehsil Chilly Pingal and started hue and cry against Govt. and Administration.

xi). DDR No. 15 dated 01-05-2024 of P/S Gandoh.

On 01-05-2024 a report vide DDR No. 15 dated 01-05-2024 was entered in the daily diary of P/S Gandoh to the effect that History Sheeter Mehraj Din S/O Shamas Din R/O Tandla Tehsil Chilly Pingal(subject), who is a history sheeter since year 2017 as per record of PS, and who is contesting independently for Lok Sabha election 2024 from Udhampur constituency, and provoking the people of Gandoh area especially Tehsil Chilly Pingal, entered Govt. offices and started hue and cry against Govt. and Administration.

xii). DDR No. 14 dated 13-07-2024 of P/S Gandoh.

On 13-07-2024 a report vide DDR No. 14 dated 13-07-2024 was entered in the daily diary of P/S Gandoh to the effect that it was learnt through reliable sources that on 13-06-2024 an accident took place at near Bhatyas where public has gathered and DDC member Kahara Mehraj Din Malik S/o Shamas Din Malik R/o Tandla Tehsil Chilly Pingal (subject) is provoking the people there against R&B Department and also threatened to fire the office. On this 126/136 BNSS report was entered in daily diary and preventive action will be produced before the court of law. Further, the complainant U/S 126/136 BNSS was produced against the subject before EMIC Gandoh .

xiii) DDR NO.27 DATED 05-01-2025 OF PS DODA.

On 05-01-2025 a report vide DDR No. 27 was entered in the daily diary of P/S Doda to the effect that it is found that a Facebook post in the name/ID of Mehraj Malik (subject) got viral in which it is written that if administration doesn't take any action against mafia get ready for Doda chalo on 7/8 Jan against mafia. I will come with full power. No mafia in my Distt! on more post, iske baap ko be rikshaw se adda nahi lena dunga, recovery me iska ghar bhi jayega.koie adda nahi dega e rikshaw wala.me parsu Doda aarha hu.tab tak administration ke action ka intzaar hai.

xiv) DDR NO.45 DATED 07-09-2025 OF PS Thathri.

On 07-09-2025 a report vide DDR No. 45 was entered in the daily diary of P/S Thathri to the effect that a dispute is going on between the Hon'ble MLA Doda Mehraj Malik (subject) and civil administration regarding PHC at Kencha Tehsil Kahara due to which a lot of activity is going on in the area for one to two days . In this regard Hon'ble MLA Doda is trying to instigate the people quite actively on the social media also and is using unparliamentarily words against civil administration particularly DC Doda. Today Hon'ble MLA Doda is stayed at Dakbanglow Thathri where from he has again used unparliamentarily words against DC Doda and administration and instigating the public after getting live on his own social network site Face book account. The Police personnel of Police Station Thathri are deployed at Dakbanglow and all the Police posts etc. of the area have also been directed regarding the activities and security of

Hon'ble MLA. Senior officers have also been informed regarding his stay at Dakbanglow.

xv) DDR NO.14 DATED 07-09-2025 OF PS Doda.

On 07-09-2025 a report vide DDR No. 14 was entered in the daily diary of P/S Doda to the effect that at this time an information has been received from reliable sources at this Police Station that the Sikh community has held a protest at Gurudwara Saw Mohalla as MLA Doda Mehraj Malik (subject) has uploaded a video on social media in which he has abused the Deputy Commissioner Doda Harvinder Singh and has said that DC Doda is a thief and he will spit on his face. Due to this the sentiments of the Sikh community have got hurt. MLA Doda wants to disturb the peaceful atmosphere and communal harmony in District Doda, due to which there can be law & order problem in the District particularly Doda town.

xvi) DDR NO.25 DATED 07-09-2025 OF PS Thathri.

On 07-09-2025 a report vide DDR No. 25 was entered in the daily diary of P/S Thathri to the effect that a dispute is going on between the Hon'ble MLA Doda Mehraj Malik (subject) and civil administration regarding PHC at Kencha Tehsil Kahara due to which a lot of activity is going on in the area for some days . In this regard Hon'ble MLA Doda is trying to instigate the people quite actively on the social media also and is using unparliamentarily words against civil administration particularly DC Doda. MLA Doda getting live on his own social network site Facebook account on being asked by the reporter in interview as to whether consuming chitta gives wisdom, has replied that DC Doda should use some addictive substance so that he will get wisdom by consuming chitta because he has 462K followers on social media account. Since there is lot of population of young addicts in the UT and he has a lot of followers due to which there can be a bad impact on addicted youth as well as common people of the area. There can be danger to peaceful atmosphere in the area. Hon'ble MLA has indulged in instigating the public through social media, due to which there is apprehension that at any time there can be disturbance to peaceful atmosphere and law & order problem. Previously there is also a DDR No. 45 dated 07-09-2025 entered against him.

3. From the perusal of the above-referred FIRs and DD reports, it is evident that the subject consistently behaves like a habitual goon, determined to transform society into a lawless, muscle-powered community by getting illegal things done through intimidation, force, heckling / physical assault and creating hostage situations. The multiple FIRs and DD reports, out of which some have been compounded or closed, reveal that despite numerous legal actions taken against him, he remains unrepentant and continues to operate in an organized and calculated manner to push society towards lawlessness and violence. His continuous activities aim to disturb public order by misguiding and exploiting the youth, channelizing their energy against law-abiding elements of society, and attempting to foment unrest and rebellion against the state and public order. The criminal actions of the subject have had a serious adverse impact on public order, peace, and tranquility in the area. Despite being booked under various legal provisions, the subject has grown increasingly defiant and fearless, showing no signs of reform, and persistently engaging in activities that threaten public order in a sensitive district like Doda, currently reeling with large scale damages due to floods and landslides and his activities are aimed at disrupting Government's relief and reconstruction measures and projecting the entire government in bad light further alienating the youth.

4. The subject also has a documented history of associating himself with proscribed terrorists such as Burhan Wani through provocative social media posts and calling for his lakhs of followers to act as 'Lashkars' against the state. On one occasion, he even issued a public call to burn down government offices, for which a Daily Diary report has been duly recorded at PS Gandoh.

5. Furthermore, during the nationwide Operation Sindoor, an initiative aimed at countering elements attempting to divide the nation along religious and regional lines the subject openly issued threats to government officials within his constituency and sought to incite public hostility against the Administration. Multiple FIRs have been registered against him for unlawful acts, including forcibly locking government offices and verbally and physically attacking public servants on several occasions.

6. As already stated, the subject's provocative speeches and 'Facebook Lives' has been continuously misused by him to spread misinformation and provoke public to cause public order issues. Every lawful action by administration aimed at creating a law based society, whether conducted in District Doda or in Jammu, gives the subject an 'opportunity' to spread lies and provoke public especially youth to cause large scale breach of peace appealing them on emotional grounds and poverty even for legal action by authorities against big showrooms as evident from FIR No. 55/2023 lodged at PS Bahu Fort and communication No. MC/D/2025 131-32 dated:- 18.04.2025 against the subject's illegal activities. The subject deliberately misrepresents the lawful actions of government as unlawful through his social media posts, thereby obstructing official duties and attempting to incite public unrest.

7. The subject's continuous activities of showing every legal action of Administration in bad taste coupled with misinformation and provocative words by and elected representative has every propensity to alienate the youth from adopting legal means and abiding with the law of land, especially when the subject continuously makes open remarks that he is above law and law does not apply to him being a lawmaker in the Legislative Assembly of UT of Jammu and Kashmir.

8. Whereas, in one of the FIRs above, coupled with a letter from the Principal, Govt. Medical College, Doda vide No. GMC/D/PS/1015-1021 dated:- 29.05.2025, it has been reported that the subject does not even respect the dignity of women and has made repeated derogatory, threatening and misogynistic remarks against lady doctors serving at GMC Doda, threatening to "drag and undress" them at his will. His irresponsible remarks against females coupled with his 'dictionary' having words like "muh par thukunga" (will spit on face), Dalla (pimp/broker of illegal activities), etc have degraded the ethical conduct of society, especially the youth who now have started feeling that law is only for the weak to follow and are towing the subject's line to offend and break rules as a habit. These activities of subject and resultant action of youth following him has many a times brought to standstill the entire government machinery especially emergency services at Associated Hospital, GMC Doda on 29.05.2025, cleanliness activities by Municipality staff on another occasion and relief / restoration work in Tehsil Kahara in the aftermath of disaster induced losses on 05.09.2025.
9. In the interest of society and in view of the subject's regular habit of issuing threats and carrying out physical assault of people, including Govt. officials coupled with his habit of spreading misinformation, call for undressing women, glorification of proscribed terrorists and drug abuse and activities aimed at disturbing communal peace and order, it has been recommended through the police Dossier that the subject **Mehraj Din Malik S/o Shamas Din R/o Tandla Tehsil Chilly Pingal, District Doda** be detained under the provisions of Public Safety Act, 1978 for a maximum period.

- 10 The liberty of a citizen is undoubtedly important but this has to balance with the safety of the community, especially when an individual openly questions law of land, repeatedly terming himself 'above law' and resorting to violence & instigation to pull youth towards disorder. A balance is required to be maintained between the personal liberty of the subject, his right as legislator to raise important public issues within the ambit of law and the peace, tranquility and safe future of the society. It is the right of the society to be shielded from the hazards of being exposed to the criminal misadventures of the subject who, at the current moment, is an imminent threat to not just the peaceful existence of community life and a rule based society but is also hindering restoration of public services, distribution of relief material and rebuilding the lives of the affected people of the District .
- 11 Whereas, clearly, the subject along with his associates, tries to instigate public, especially youth, to follow the path of disorder and chaos. The subject does not believe in peaceful resolution of matters through means available under law. Having no respect for harmonious coexistence and always behaving in an inappropriate manner causing unrest and violence, it has become his daily habit, which is fancied by lakhs of youth following him, who unknowingly get motivated to walk his dangerous path. In view of the gravity of his regular involvement in anti-social and criminal activities and his consistent determination of not correcting himself, in the best interest of the society and public order and to deter him from becoming a larger threat to the safety of public, it can be satisfactorily concluded and has become clear that his remaining at large will definitely have an adverse impact on the peace and public order in the District, which demands his immediate detention.
