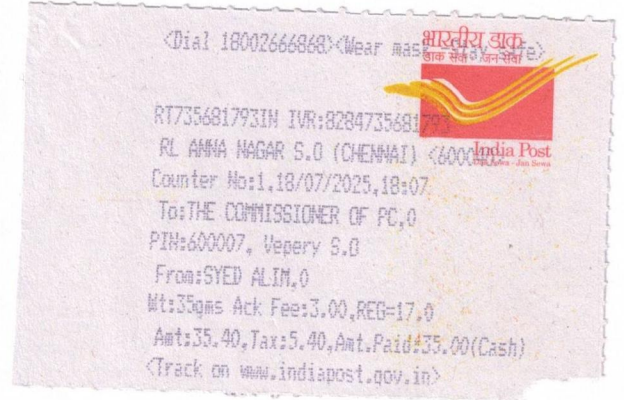

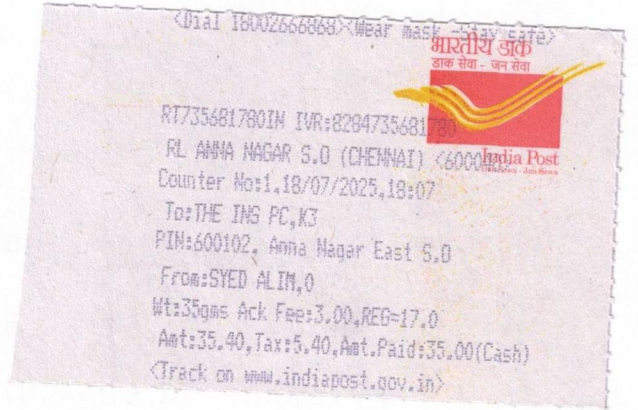

SUBJECT: Complaint against Tamil Television Actor Mr. Ravichandran for Defamatory, Derogatory, and Hatefull Speech against Mr. K. Selvaperunthagai, State President – Tamil Nadu Congress Party.

I, H. Syed Alim, S/o. Mr. Hayath Basha, aged 35 years, residing at the address mentioned above, am a practicing Advocate at the Hon'ble Madras High Court, currently serving as the State General Secretary of the Tamil Nadu Youth Congress, and as a Spokesperson of the Tamil Nadu Congress Committee. I wish to bring to your attention the following facts which warrant immediate legal action.

1. That Mr. K. Selvaperunthagai, Hon'ble MLA and the State President of the Tamil Nadu Congress Party, had addressed a recent press conference wherein he expressed his opinion and comments in response to questions raised by the media concerning the Lord Murugan Conference.
2. I humbly submit that, on 08.07.2025, the serial actor and Tamil TV actor named Mr.Ravichandran interview aired on the "**IB News**" YouTube channel, in which he stated defamatory statements against the President of the Tamil Nadu Congress Party, Mr.K.Selvaperunthagai.
3. I humbly submit that Mr.K.Selvaperunthagai is a Public Representative; he has every right and audacity to support, criticize the Political Matters as well as the public-engaged matters, likewise, he shared some heard facts about the Lord Murugan conference.
4. I humbly submit that, Mere sharing his opinion about the lord Murugan conference, Mr.K.Selvaperunthagai was verbally abused by Mr.Ravichandran in the Public Media with the intent to tarnish the personal and political reputation of Mr. Selvaperunthagai and were filled

with abusive, caste-insensitive, and hateful language aimed at provoking public outrage.

5. I humbly submit that Mr.Ravichandran, as an attention seeker he started defaming several celebrities as well as politicians to gain attention from the common public as well as to gain an illegal means of advantage from the said current Sensitive and hot-button issue.
6. I humbly submit that Mr.Ravichandran is a small-scale TV industrial serial actor who does not reach up the Television heights can't able to shine on the silver screen due to his poor skills to gain fame in the television industry. He intentionally started giving interviews to YouTube channels and news channels by abusing and attacking the reputable individuals on social platforms.
7. I humbly submit that Mr. Ravichandran is inducing and encouraging other individuals by publicly defaming and abusing the Reputed individuals in the society.
8. I humbly submit that as a state president of the Tamil Nadu Congress Party, Mr.K.Selvaperunthagai does not encourage violence and supports the unlawful activities as stated in the **IB NEWS Channel**.
9. I humbly submit that in the above-stated Interview given by Mr.Ravichandran, He accused Mr. Selvaperunthagai as a as a history sheeter, murderer, fraud, and dishonorable person, which are serious defamatory accusations with no basis , on the IB News Channel interview to defame him.

10. That Mr. Ravichandran made a direct and brutal character attack on Mr. K. Selvaperunthagai by using the following highly insulting and defamatory Tamil words on public media:

- "மானம் கெட்டவன்" – shameless fellow
- "திருட்டுபயன்" – thief
- "நாய்பயன்" – dog
- "திருட்டுக்கமுனாட்டி" – cunning criminal
- "அயோக்கிய பயன்" – Unfaithful and cheater /scoundrel
- "கொலைகாரன் / கொல்லகாரன்" –murderer/ robbery man

11. These words were used intentionally to Shame and insult an public elected leader, Damage his public image, Trigger hate and provoke unrest among the public and to Gain cheap popularity and media attention. This kind of language, especially against a respected MLA, is not only vulgar and unacceptable but also a serious criminal offence. It shows a clear intention to defame and disturb public peace, and it cannot be tolerated in a democratic society.

12. I humbly submit that, at the outset of the 2026 State election, Mr.Ravichandran is used as a decoy expert and trickster by the various Tamil Nadu state parties by lowering their standards and using Political Tactics to defame the Majority alliance and to secure the maximum level of vote percentage in the upcoming 17th Tamil Nadu state legislative assembly election.

13. I humbly submit that spreading such baseless and disrespectful narratives could lead to misinformation and foster a culture of disrespect for our leader. While the Constitution of India guarantees freedom of speech, **Article 19(1)(a)**, it is subject to reasonable restrictions under **Article 19(2)** in the interest of public order, decency, and morality—all of which have been grossly violated in this instance, these Comments exceed the boundaries by defaming and insulting.
14. That the said video content is still available on the “IB News” YouTube channel and is being circulated across various social media platforms, causing ongoing reputational damage and emotional distress.
15. That I, as a party functionary and responsible citizen, am personally aggrieved by these offensive statements which have deeply impacted the morale of our political workers and supporters. That such conduct has become a pattern among fringe personalities and must be curbed to uphold the integrity of democratic debate and public discourse.
16. That these statements, made publicly through a digital platform, amount to **criminal defamation** under Sections 499 and 500 IPC / Sections 356(1) & 356(2) BNS, and are clearly **intended to provoke unrest** in violation of Section 504 IPC / Section 352 BNS. That the remarks are also in violation of the Information Technology Act, 2000, as they constitute **cyber abuse**, hate speech, and **online harassment of a public figure**.

17. These abusive remarks have caused immense mental agony to me and many other citizens who respect Mr.K.Selvaperunthagai. Such hate speech also poses a threat to public order.
18. That Mr. Ravichandran has no known political or journalistic standing, and has attempted to gain personal and professional visibility by resorting to scandalous and slanderous remarks against respected individuals. That such statements directly affect the mental well-being of Mr. Selvaperunthagai's followers, party cadre, and the general public who look up to him as a dignified political leader.
19. I humbly submit that, as a public representative of the Tamil Nadu Congress Party Mr.Ravichandran, this is a great disrespect to the party as well as the president the above-stated derogatory statement against Mr.K.Selvaperunthagai should be stopped and the video uploaded on Ilaya Bharatam YouTube news channel should be removed.
20. That it is imperative to prevent the continued circulation of this defamatory content and to prosecute the offender under all applicable laws to preserve the dignity of our democratic institutions and political representatives.
21. Therefore, I most respectfully request your good offices to:
 - a) Register an FIR against Mr. Ravichandran under appropriate sections of the IPC, BNS, and IT Act.

- b)** Initiate an investigation by collecting the said video content, interview transcripts, social media posts, and any supporting digital evidence.
- c)** Instruct the relevant authorities or platforms to remove the defamatory video from public access.
- d)** Take appropriate preventive measures to ensure no such defamatory content is allowed to be published or circulated in the future.

I am willing to cooperate fully and provide further details or evidence, if necessary, to aid in the investigation. I kindly request you to take strict legal action against Mr. Ravichanran under relevant sections of the law to prevent such offensive acts in the future. I trust that you will take this matter on serious note and act accordingly

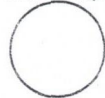

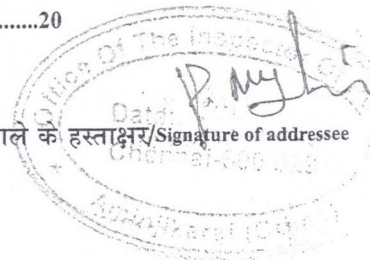
