## **PRESS NOTE**

### **I. Special Summary Revision 2026:**

#### **1. Pre-revision Activities:**

Special Summary Revision of Electoral Rolls w.r.t qualifying date 01.01.2026 is under progress in 24-Bagalkot and 107-Davangere South Assembly Constituencies (ACs) of Karnataka State as per the directions of the Election Commission of India.

Draft Electoral Rolls for above 2 Assembly Constituencies have been published in the offices of Deputy Commissioners of Bagalkot and Davanagere districts, Electoral Registration Officers, Assistant Electoral Roll Registration Officers and all polling stations coming under the jurisdiction for the information of public on 03.01.2026.

#### **2. Revision Activities:**

The schedule for revision Activities of Special Summary Revision of Electoral Rolls 24-Bagalkot and 107-Davangere South Assembly Constituencies is as below:

The Special Summary Revision of Electoral Rolls is under progress as per the above schedule. Cooperation of the political parties and general public is sought on the following points:

- a. Draft Electoral Rolls of the Assembly constituencies will be published in the official website of the Chief Electoral Officer, Karnataka (<https://ceo.karnataka.gov.in/en/>) in PDF formats and also in the respective DEO's websites. The general public are requested to check as to whether their names have been included in the list with correct information.

**b. Method of submission of applications:**

Applications are required to be submitted to the notified Electoral Registration Officer/Assistant Electoral Registration Officer of Assembly Constituency in prescribed forms along with required documents.

i. **Form 6:** Application Form for New Voters

ii. **Form 6A:** Application for inclusion of name in Electoral Roll by an overseas Indian elector.

iii. **Form 7:** Application Form for Objection for Proposed Inclusion/ Deletion of Name in Existing Electoral Roll

iv. **Form 8:** Application Form for shifting of Residence/Correction of Entries in Existing Electoral Roll/Replacement of EPIC/Marking of PwD.

The above applications can be submitted online mode using the Voters Service Portal (<https://voters.eci.gov.in/>) or the Voter Helpline Mobile app. At State level, wide publicity has been given about the Special Summary Revision of the Electoral Rolls through Press Notes to create awareness among the general public. The District Election Officers at the district level and the Electoral Registration Officers/Assistant Electoral Registration Officers at Sub Division/Taluk level have also given publicity regarding Special Summary Revision through various media.

**4. Booth Level Agent (BLA):**

As per the direction of the Election Commission of India, the Registered and Recognized Political Parties are requested to appoint Booth Level Agents in every Polling Booth and to extend all cooperation to the BLOs in enrolment of all eligible voters which will be helpful in claims and objection period.

**5. Appeal:**

Action has been taken to enrol all eligible voters in the electoral rolls and for preparation of error free healthy electoral rolls in 24-Bagalkot and 107-Davangere South Assembly Constituencies. It is requested to give wide publicity to the general public to submit relevant forms during the period of claims and objections as per the above schedule of Special Summary Revision.

Eligible voters can download Voter Helpline App in their mobile phone for submitting the applications. They can also submit the applications on <https://voters.eci.gov.in/> portal. Information related to submission of applications on the above platforms is enclosed herewith.

The District Election Officers, Electoral Registration Officers, Assistant Electoral Registration Officers and Booth Level Officers concerned may be contacted for any information related to electoral rolls, Electors Photo Identity Cards and Submission of applications.

It may also be publicized that there will not be any provision to carry out any changes in the electoral rolls on the day of poll and therefore, the voters may check and verify their names in the electoral rolls immediately.
