NOTICE INVITING TENDER

Executive Engineer, Bomdila Division, PWD, Bomdila, Arunachal Pradesh on behalf of the Governor of Arunachal Pradesh invites online tender on item rate basis in single bid envelope system from approved/registered Contractors of Class -III & II categories domiciled within the territorial jurisdiction of **7-Bomdila (ST) Assembly constituency, West Kameng District** as per Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Professional) Act 2015 and in accordance with Govt. of Arunachal Pradesh Extraordinary Gazette notification No.247, Vol.XXVII ,November 2 , 2020 with up to date amendments for the following work.

- 1.1 The enlistment of the contractors should be valid on the last date of submission of Bids. In case the last date of submission of Bid is extended, the enlistment of contractor should be valid on the original date of submission of Bids.
- 1.2 The work is estimated to cost **Rs.1,97,12,147.00**.The estimated cost, however, is given merely as a rough guide.
- 1.3 Intending bidders is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below :-

1.4 **To become eligible for issue of bid, the bidders shall have to furnish the following documents:**

I/We undertake and confirm that eligible similar work(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/We shall be debarred for bidding in PWD in future forever. Also, if such a violation comes to notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/ Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid)

For the purpose of this clause 'similar work' means the works of "**Road work including protection works etc.**"

2. Agreement shall be drawn with the successful tenderer on prescribed Form No. CPWD 8 which is available as a Government of India Publication. Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the Agreement.
3. The time allowed for carrying out the work will be **24 (Twenty Four) months** from the 10th day after the date of written orders to commence the work or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
4. The site for the work is available.
5. The bid document consisting of specifications, the schedule of quantities of various types of Road works to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.arunachaltenders.gov.in
6. Earnest money For 1) Rs. 1,97,100.00 for APST category and 2) Rs. 3,94,200.00 for Non APST in the form of Receipt of STDR of a scheduled bank/fixed deposit receipt of a scheduled bank issued in favour of Executive Engineer, Bomdila Division, PWD, Bomdila. Payable at State Bank of India, Bomdila Branch (IFSC Code **SBIN0001394**)

Online bid documents submitted by intending bidders shall be opened only of those bidders, who has deposited e-Tender Processing Fee of ₹ 2,000/ (Two thousand) only non refundable and receipt of Earnest Money Deposit from the office of the Executive Engineer, Bomdila Division, PWD which shall be issued on receipt of original EMD prior to on or before one day of last date 11/03/2024 upto 11:00 hrs and other documents scanned and uploaded are found in order.

The bid submitted shall be opened at **16:30 hrs on 11/03/2024**.

7. The bid submitted shall become invalid and e-Tender processing fee shall not be refunded if:
 - i) The bidder is found ineligible.
 - ii) The bidder does not upload all the documents (including service tax registration as stipulated in the bid document including the deposition of physical EMD) at the date & time specified in the Bid.
 - iii) **If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the bidder in the office of bid opening authority.**
 - iv) **If the tenderer quotes nil rates against item in item rate tender or any section, the tender shall be treated as invalid and will not be considered as lowest tenderer.**
8. The contractor whose bid is accepted will be required to furnish performance guarantee of 5% (Five Percent) of the bid amount within the period specified in Schedule "F". This guarantee shall be in the form of STDR/TDR of any scheduled bank, STDR/TDR of any Scheduled Bank of any scheduled bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F' including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The Earnest Money deposited along with bid shall be returned after receiving the aforesaid performance guarantee. (Modified vide OM DG/CON/273 dt. 01.10.2013)



9. The description of the work is as follows "**Construction of CC Steps within Bomdila township (SH: Bazar Line Area, Bazar Line to Medical Colony, Bazar Line to Forest Colony and DC'S Office).**"

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or effect their tender. The tenderer shall be responsible for arranging and maintaining at his own cost all materials tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plants etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

10. Any contractor who has 3 (Three) or more uncompleted ongoing commitment (projects to execute/contracts at hand) is not permitted to participate in this tendering. The tenderer will invariably submit an affidavit sworn before a competent Magistrate to the effect that he does not have 3 (three) or more uncompleted ongoing commitments at the time of tendering. The affidavit should mention the names of the uncompleted ongoing commitments. He shall also, for participation in any tender be required to submit completion certificate issued by the Engineer-in-charge duly counter signed by the concerned Superintending Engineer. Any tender which does not fulfill this condition will be summarily rejected. In the event of submission of false information, which may be detected by the department after award of work, the tender shall be cancelled immediately and the contractor shall be barred from further participation in any tender works of the department.

11. The tenderer will have to submit **No Due Certificate (NDC) / No Objection Certificate (NOC)** from Arunachal Pradesh State cooperative Apex bank Limited, not older than 3(three) months, duly issued by the Managing Director cum Chief Executive Officer , Itanagar along with the tender.

12. All the required information and documents should be submitted strictly in the formats given in the tender document. Other standard formats may be adopted only in cases where no formats have been prescribed in the tender document.

13. The competent authority on behalf of Governor of Arunachal Pradesh does not bind to accept the lowest or any other tender and reserves to itself the authority to reject any or all of the tenders received without the assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.

14. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.

15. The competent authority on behalf of Governor of Arunachal Pradesh reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

16. The contractor shall not be permitted to tender for works in the PWD Circle (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Public works Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.



17. No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of Arunachal Pradesh is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of Arunachal Pradesh in writing. The contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of Arunachal Pradesh as aforesaid before submission of the tender or engagement in the contractor's service.
18. The tender for the works shall remain open for acceptance for a period of **45** days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% for the said earnest money as aforesaid. Further the bidder shall not be allowed to participate in the re-bidding process of the work.
19. The tenderer/ his representative should visit the site and a certificate of which issued by AE/ EE-in charge of work should invariably be uploaded by the tenderer alongwith other tender documents.
20. The tender accepting authority reserves the right to accept or reject any tender and to cancel the tendering process and reject all tenders at any time prior to the award of contract without assigning any reasons, thereby incurring any liability to the affected tenderer or tenderers on any obligation to inform the affected tenderer or tenderers of the grounds for the tender accepting authority's action.
21. This Notice Inviting Tender shall form a part of the contract documents. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 7 days from the stipulated date of start of the work sign the contract consisting of: -
 - a) The Notice Inviting Tender, all the documents including additional conditions specifications and drawings, if any, forming part of the tender as uploaded at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
 - b) Standard CPWD Form.
