1. Leave granted.
2. We have heard the learned counsel appearing for the appellants and the learned counsel appearing for the respondent.
3. The appellants have been arrayed as accused for the offences punishable under Sections 143, 147, 148, 353, 333, 332, 436, 427 and 149 of the Indian Penal Code, 1860 and under Sections 16, 18 and 20 of the Unlawful Activities (Prevention) Act, 1967 and Section 2 of the Prevention of Destruction and Loss of Property Act, 1981.

4. We have perused the charges framed. The appellants have been under incarceration for more than five years. There are 254 witnesses to be examined. The appellants are two amongst the 138 accused persons.
5. Taking note of the aforesaid facts, we have no hesitation in setting aside the impugned order(s) and grant bail to the appellants.
6. Accordingly, the impugned order(s) stand set aside and the appellants are granted bail, subject to the terms and conditions that may be imposed by the Trial Court.
7. The appeals are allowed, accordingly.
