The allegations mentioned in the complaint prima-facie, discloses commission of cognizable offences punishable under section 13(2) r/w 13(1)(b) of PC Act, 1988(as amended in 2018) & 61(2) BNS 2023 against Sh. H. S. Bhullar, DIG, IPS:2009, Punjab Cadre and unknown others.

A Regular Case is therefore registered under section 13(2) r/w 13(1)(b) of PC Act, 1988 (as amended in 2018) & 61(2) BNS 2023 and substantive offences thereof against Sh. H S Bhullar, DIG, IPS:2009, Punjab Cadre and unknown others and entrusted to Sh. Kuldeep Singh, CBI, ACB, Chandigarh for investigation.

Sub: Complaint against Sh. Harcharan Singh Bhullar, IPS, DIG (Ropar Range),

Punjab Police for possession of Disproportionate Assets.

Sir,

A regular case no. RC0052025A0019 dated 16.10.2025 was registered U/s 61 (2) BNS 2023and Section 7 & 7A of PC Act, 1988 (as amended in 2018) against Sh. Harcharan Singh Bhullar, IPS, DIG (Ropar Range), Punjab Police and Sh. Kirshanu, Private Person on the basis of complaint dated 11.10.2025 of Sh.Akash Batta r/o Mandi Gobindgarh, Punjab and verification report dated 15.10.2025. Accordingly, a trap was laid, during which accused Kirshanu, middleman was caught red handed while accepting the bribe amount of RS. 5 lakh from complainant, on behalf of accused H.S Bhullar. Subsequently, Harcharan Singh Bhullar, IPS, the then DIG (Ropar Range) and middleman Kirshanu were arrested for demanding and accepting illegal gratification of Rs. 5 lakh from complainant Akash Batta.

In continuation of the investigation of said case, residential premises of accused Harcharan Singh Bhullar at House No. 1489, Sector 40B, Chandigarh, was searched on 16/17.10.2025. During the search, cash amounting to Rs. 7,36,90,000/- was recovered, out of which Rs. 7,36,50,000/- was seized vide Search List dated 16/17.10.2025. Further, Gold Jewellery & silver items for total value of Rs. 2,32,07,686/- (from the bedroom of Harcharan Singh Bhullar), 26 Branded & expensive watches were also recovered. Immovable property documents were also seized, which include documents of H.No.1489, Sector 40-B, Chandigarh and Flat No.1014, Sector 39, Chandigarh and documents pertaining to acquisition of agricultural land measuring around 150 acres in the districts of Mohali, Hoshiarpur and Ludhiana and commercial properties in the name of Sh.H.S. Bhullar, his family members (comprising of wife Smt.Tejinder Kaur Bhullar, son Shri Gurpartap Singh Bhullar and daughter Ms Tejkiran Kaur Bhullar) and others. Shri Harcharan Singh Bhullar and his family members were also found to be in possession of five vehicles including high-end vehicles such as Mercedes, Audi, Innova and Fortuner. There is a balance of Rs.2.95 crores (approximately) as on 17.10.2025

in five bank accounts and two Fixed Deposits (FDs) in the name of Shri Harcharan Singh Bhullar and his family members.

As per salary account No. 50100005633061 of Shri Harcharan Singh Bhullar in HDFC Bank, Sec 9 Chandigarh, net salary to the tune of Rs.4,74,140/- for the month of August, 2025 and September 2025 was credited during the check period from 01.08.2025 to 17.10.2025. As per Income Tax Return for the Assessment Year 2025-26, Shri Harcharan Singh Bhullar has declared his total income from all known sources to the tune of Rs.45,95,990/-. Further, income tax of Rs.13,82,270/- is paid by Shri H.S. Bhullar on the said total income and as such his net income, after deduction of income tax, is Rs. 32 lakh approx. for the whole financial year 2024-2025.

The recovery of **Rs. 7,36,90,000/-**, in cash, from the residence of Sh. H.S. Bhullar at Chandigarh, along with high-value jewellery valued to **Rs. 2,32,07,686/-**, luxury items, high-end vehicles and substantial bank balances/fixed deposits, prima facie reveal that during the check period from 01.08.2025 to 17.10.2025, accused Sh. Harcharan Singh Bhullar, IPS: 2009, Punjab Cadre, in connivance with unknown others, has acquired assets disproportionate to his known sources of income, thereby intentionally enriched himself illicitly during the period of his office, for which Sh.Harcharan Singh Bhullar could not satisfactorily account for. This constitutes an offence punishable under Section 13(1)(b) read with Section 13(2) of the Prevention of Corruption Act, 1988 (as amended in 2018) and 61(2) of BNS 2023. The acquisition of immovable properties and other assets, India and abroad, may be examined in detail during the course of investigation.

Check period from 1.08.2025 to 17.10.2025 has been fixed provisionally based on recovery and seizure from the residence of the public servant and preliminary scrutiny of the record. The period may be modified/reviewed during the course of investigation after verification of additional assets and sources of illicit enrichment.

In view of the above facts and circumstances, it is recommended that a regular case/FIR under Section 13(2) read with Section 13(1)(b) of the Prevention of Corruption Act, 1988 (as amended in 2018) and 61(2) of BNS 2023 be registered against Sh.

Harcharan Singh Bhullar, IPS:2009, Punjab Cadre and unknown others. The role of family members, who may have abetted Sh. Harcharan Singh Bhullar in acquiring assets disproportionate to his known sources of income, may be looked into during the course of investigation.
